Public Protection Policy Development and Review Panel

#### 1. APOLOGIES FOR ABSENCE

An apology for absence was received from Councillor Mrs P M Bryant.

#### 2. MINUTES

It was AGREED that the minutes of the meeting of the Public Protection Policy Development and Review Panel held on 17 January 2017 be confirmed and signed as a correct record.

#### 3. CHAIRMAN'S ANNOUNCEMENTS

There were no Chairman's announcements.

### 4. DECLARATIONS OF INTEREST AND DISCLOSURES OF ADVICE OR DIRECTIONS

There were no declarations of interest or disclosures of advice or directions made at this meeting.

#### 5. **DEPUTATIONS**

There were no deputations made at this meeting.

#### 6. AIR QUALITY ACTION PLAN UPDATE

The Panel considered a report by the Director of Planning and Regulation on Air Quality in the Borough which gave an update on the Air Quality Action Plan.

At the invitation of the Chairman, Councillor Cartwright, the Executive Member for Public Protection, addressed the Panel on this item.

In addition to the information provided in the report, Members were advised that whilst District Councils have responsibilities in respect of Air Quality, they have no control over the local road network that is the pre-dominant cause of exceedances of Air Quality targets. It was discussed and agreed that once the government has published the new Air Quality Action Plan for the UK and it is clearer what action Fareham needs to take in respect of Air Quality, it may be worth considering the possibility of re-establishing the Air Quality Steering Group to enable multi agency collaboration in tackling air quality issues in the Borough.

Members commented that the report provided was extremely informative and, given that Air Quality is such a topical issue at the moment, it would be useful to make the report available to all Members of the Council.

Members enquired whether the extended Air Quality Management Area outlined in Appendix C of the report encompasses Redlands Lane school. The Head of Environmental Health agreed to check whether this is the case and report back.

The Panel requested that information be made available regarding usage rates of the two electric vehicle charging points that have been installed in the Borough. The Head of Environmental Health agreed to provide a verbal update on this at the next meeting.

It was AGREED that the Panel notes:

- (a) the content of the report and the progress that has been made to date in respect of Local Air Quality Management; and
- (b) that a report will be presented to the Executive regarding the new UK Air Quality Action Plan and its implications to Fareham when more detail about it is known.

## 7. ANNUAL UPDATE ON FAREHAM COMMUNITY SAFETY PARTNERSHIP & POLICE CRIME PANEL

The Panel considered a report by the Director of Planning and Regulation which gave an overview of the work undertaken by Fareham's Community Safety Partnership and provided an update on the Partnership's performance to date.

At the invitation of the Chairman, Council T M Cartwright addressed the Panel on this item.

Members commented on the very successful Community Safety initiatives that take place across the Borough and commended the excellent work of the Partnership Action Group.

Councillor Cartwright reported on Hampshire Constabulary's HMIC Inspection. It is part three of their 2016 PEEL Inspection process. For the previous two (efficiency and legitimacy) Hampshire Constabulary was graded as 'good'. This one focuses on effectiveness and was conducted in Autumn 2016, just prior to the Joint Inspection (JTAI) conducted in Hampshire on Domestic Abuse. The report talks a lot about the positive work Hampshire Constabulary is doing in terms of its commitment to neighbourhood policing, taking on organised criminals, and a good response to tackling anti-social behaviour. Hampshire Constabulary are also pleased that their officers are listening to the views of victims and that 'without exception' their staff and officers have good knowledge of vulnerability including child sexual exploitation, modern slavery and domestic abuse. Areas for improvement focus on the Force's response to domestic abuse. Councillor Cartwright advised that the Chief Inspector is already taking steps to improve performance in this area.

Councillor Cartwright also provided a brief update on the Police Crime Panel, advising that the Delivery Plan has now been received by the Panel but, disappointingly, it does not provide any clarity on how achievements will be measured. The Police Crime Commissioner has now agreed the precept for this year which has been increased due to a reduction in government funding. The Finance Working Group will probe what the additional money will be spent on. It was AGREED that the Panel note the performance and progress made by Fareham's Community Safety Partnership and the risks and challenges it faces in the future.

#### 8. FINAL REVIEW OF ANNUAL WORK PROGRAMME FOR 2016/17 AND FINAL CONSIDERATION OF DRAFT WORK PROGRAMME FOR 2017/18

The Panel considered a report by the Director of Planning and Regulation which gave a final review of the Work Programme for 2016/17 and the draft Work Programme for 2017/18.

The Director of Planning and Regulation drew the Panel's attention to Appendix C of the report which sets out details of the proposed items for consideration during 2017/18. Members requested that an update regarding the recently implemented Public Spaces Protection Order be added to the July meeting of the Work Programme.

It was AGREED that Members:-

- (a) reviewed the Panel's Work Programme for the current year 2016/17;
- (b) agreed a proposed Work Programme for 2017/18, subject to the inclusion of an update on the recently implemented Public Spaces Protection Order at the July 2017 meeting; and
- (c) submit the proposed Work Programme for 2017/18 to the Council for endorsement.

It was AGREED that the minutes of the Health and Housing Policy Development and Review Panel held on 19 January 2017 be confirmed and signed as a correct record.

#### 3. CHAIRMAN'S ANNOUNCEMENTS

There were no Chairman's announcements.

## 4. DECLARATIONS OF INTEREST AND DISCLOSURES OF ADVICE OR DIRECTIONS

There were no declarations of interest or disclosures of advice or directions made at this meeting.

#### 5. **DEPUTATIONS**

There were no deputations made at this meeting.

#### 6. HEALTH UPDATE

The Chairman provided a copy of the recent Friends of Fareham Community Hospital's newsletter as an update on local health issues.

Members noted that a Business Support Manager has now been appointed at Fareham Community Hospital.

Councillor Mrs Hockley commended the Council's "Fareham in Bloom" team for the excellent work that has been done in improving the flower beds at the Hospital entrance.

#### 7. HOMELESSNESS UPDATE

The Chairman reminded Members that at the meeting of the Council's Executive on 06 February 2017, a proposal was put forward that provision be made within the budget to fund an outreach worker to support the increasing number of rough sleepers in the Town Centre. The Executive Leader indicated that the Health and Housing and the Public Protection Development and Review Panels would be the appropriate forum to discuss the need for this resourcing and that if it were considered necessary, provision could be made

from within the existing spending reserve. Following discussions with the Executive Member for Public Protection and the Chairman of the Public Protection Policy Development and Review Panel, it has been agreed that it would be appropriate to discuss this issue at the Health and Housing Panel.

At the invitation of the Chairman, Councillor T M Cartwright MBE, Executive Member for Public Protection addressed the Panel on this item.

The Panel received a verbal update and presentation from the Housing Options Manager on Homelessness within the Borough. The presentation provided Members with an overview of the Housing Advice and Homeless Service in Fareham, highlighting the costs involved in providing this mandatory service, the advice and assistance provided, the role of the Two Saints Organisation and the Severe Weather Emergency Protocol.

Members also received a detailed update on the numbers and circumstances of the rough sleepers in the Borough who were identified from the annual 'single night snapshot' that is taken across the country using street counts and intelligence driven estimates. Of the 18 people identified, 7 were found to be engaging with local services, 2 have subsequently been sent to prison, 1 has a room at a hostel, 1 has been assisted into private rented accommodation and 1 has been supported to return to their original area. The remaining 6 people are not engaging with any interventions or assistance that is offered and there is a need to find new ways of working so that solutions can be found to secure successful outcomes for these vulnerable people. This will involve greater collaboration with partnership agencies.

Following discussion and debate it was concluded that it is clear that the issue appears to be that there is a small group of rough sleepers who, for a variety of reasons, will not engage with the appropriate agencies that could assist them.

It was AGREED that no additional budget provision for an outreach worker be made available, but that officers in the housing department be asked to review, in conjunction with other agencies, how this problem can best be tackled and to report back to the Panel at a time to be agreed. Councillor Mrs M Brady requested that it be noted in the minutes that she did not agree that additional budget provision should not be made.

The Housing Options Manager was thanked for providing an excellent presentation which was very informative.

#### 8. TENANCY MANAGEMENT REPORT

The Panel considered a report by the Director of Operations on Tenancy Management Performance.

At the invitation of the Chairman Councillors T M Cartwright, MBE and Mrs K Mandry addressed the Panel on this item.

Members enquired whether the Vanguard intervention carried out recently has resulted in easier ways for residents to make payments. The Tenancy Services Manger advised that a system is currently being implemented that will provide residents with greater flexibility and choice in respect of the direct debit payment scheme. This will enable residents to make weekly payments as an alternative to monthly payments and will make it easier for them to manage their finances.

It was AGREED that the Panel notes the information contained within the report.

## 9. FINAL REVIEW OF WORK PROGRAMME 2016/17 AND DRAFT WORK PROGRAMME 2017/18

The Panel considered a report by the Director of Operations on the final review of the Work Programme 2016/17 and the draft Work Programme for 2017/18.

Members requested that an update on Homelessness be added to the Work Programme 2017/18 at a meeting that Officers consider most appropriate.

It was AGREED that Members:-

- (a) reviewed the Panel's Work Programme for the current year 2016/17;
- (b) agreed a proposed Work Programme for 2017/18, subject to the inclusion of an Update on Homelessness at the meeting considered most appropriate by Officers; and
- (c) submits the proposed Work Programme for 2017/18 to Council for endorsement.
