Objectives:

Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

An application for community funding has been received from Emma Bazeley, Trusts and Foundations Executive for the Wessex Breast Cancer Haven in Titchfield, for the sum of £2,535 to purchase therapeutic equipment and furniture.

Breast Cancer Haven is a National Registered Charity, which aims to provide specialist therapies to assist with the emotional and physical recovery from breast cancer. The Wessex centre supports people from Hampshire, West Sussex, the Isle of Wight, Wiltshire and Dorset. Following initial consultation with each new visitor to the centre, a tailored programme of 10 complementary treatments is offered. Despite the size of its 'catchment area', of 263 visitors who benefitted from the services of the centre last year, 85 lived within the Borough of Fareham.

Breast Cancer Haven purchased the property in Titchfield in October 2015. Over the last year the Wessex centre has focussed on refurbishing the building to ensure it meets the needs of its visitors, and attracting volunteers to help with practical and administrative tasks.

During this period of establishing the service in Titchfield, the Wessex Breast Cancer Haven has identified the need for a Shiatsu mattress and perching stool to increase the variety and availability of its treatments.

In addition to providing care for clients, the Haven also hosts events, information days and training. Wessex Breast Cancer Haven has requested funding for 20 stackable chairs which would increase the number of attendees that the Haven

would be able to provide for during these sessions.

The centre's success in securing the commitment of volunteers has resulted in the need for more office furniture to accommodate them and as a result, the charity is also requesting funding for a desk, office pedestal and office chair.

Although accounts are held nationally, the Wessex centre has its own budget and has responsibility for its own fundraising. The 2015-16 Wessex area budget shows a surplus of £25,877. However, the monthly outgoings for therapist costs and overheads equates to £15,232. All income for the centre is generated by fundraising and donations.

Councillor Mrs Hockley is strongly supportive of this application, as the Haven is one of the Mayor's Charities.

Objectives:

Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

An application for community funding has been received from Paul Nicholls, Club Captain of Fareham Bowling Club, for the sum of £1,200 towards the costs of replacing an area of roofing, and installing a new entrance door and security shutters at the sports association's Clubhouse.

Fareham Bowling Club's primary objective is to provide facilities for its members to enjoy and further their interest in the sport of Flat Green Bowling. The Club is affiliated to competitive district leagues, in addition to participating in friendly matches across the central south of England. The clubhouse is located at Park Lane and is attended by 130 members and 35 associate members. In addition to engaging in bowling leagues, the Club regularly runs social events and organises 'Try for Free' events yearly to encourage newcomers to the sport.

The Club has identified necessary repairs to the Clubhouse; the entrance door is no longer fit for purpose and many of the older members are unable to open and close the door. The Club would like to replace the door, while at the same time installing a grille to increase the security of the premises. In addition, an area of the roof has developed a leak, which the Club is concerned would ultimately result in damage to the interior of the Clubhouse, and the fasciae are in need of replacement. The total cost of these repairs is £4,071.94.

The Club has benefitted from successful applications for Fareham Borough Council funding in 2012, when it was awarded £25,000 in matched funding to build new

changing rooms, and in 2014 when it received £4,999 to fund the removal of asbestos from the Clubhouse. The Club has also been very proactive in recent years in using its own funds to internally refurbish the Clubhouse, install a new kitchen area and renew 4 double glazed windows.

The Club has approached Councillor Peter Latham for a contribution from his County Councillor Funding of £1,200 towards the cost of this project. Cllr Latham is supportive of the application. As of September 2016, the Club had £12,310.51 in its accounts and proposes to allocate £1,671.94 towards the project.

Ward Councillors Mrs Bryant and Mrs Clubley are both supportive of this application.

Options Considered:
