#### **Purpose:**

This report presents an application for funding under the Council's Community Fund Programme.

An application for community funding has been received from Fareham Fireflies Netball Club, for the sum of £300 to purchase netball uniform for their Under 18s Team.

Fareham Fireflies is a local netball club which is affiliated to Hampshire Netball of the All England Netball Association Ltd. The Club runs two senior teams, one under 18 team, four under 16 teams, eight under 13 teams and three ladies teams, with each team consisting of eight players. The teams play at five secondary schools in the Borough. In addition to training and competitions, the Club run summer camps for young people wishing to try the sport.

The Club's Under 18s Team has recently been promoted to Division 4 in the Fareham and Gosport League. They currently have no uniform for this team, which will cost £300.

Fareham Fireflies have confirmed that they will display the Fareham Borough Council logo on this uniform if their application is approved.

At the end of August 2016, the Club's accounts were showing a reserve of £742.53.

#### **Purpose:**

This report presents an application for funding under the Council's Community Fund Programme.

An application for community funding has been received from the Crofton Youth Project in Stubbington, for the sum of £3,120, to replace the pendant lighting within the Crofton Youth Centre building.

Crofton Youth Project is a local charity with the key objective of providing a dedicated youth facility for young people who reside in the wards of Hill Head and Stubbington. The aim being to provide support for local young people to grow to full maturity as individuals and members of society.

The Project is currently attended by 24 young people weekly and is developing initiatives to expand this number. In addition, the Project hire the facility to a number of local community groups and services, including a carers' group, a children's activity group, a church group and a local after-school child care provider.

The Crofton Youth Project lease the building from Fareham Borough Council and have responsibility for the internal fixtures and fittings. Unfortunately, the pendant lighting within the facility has begun to deteriorate due to age, and several of the lights no longer function. As the original light fittings are now defunct, it is not possible for individual lights to be repaired.

The cost to replace the pendant lighting at the Crofton Youth Project facility has been quoted at £3,120.

At the close of September 2016 Crofton Youth Project had £12,712.31 in their accounts. This equates to approximately one year's running costs. This amount is equivalent to the financial buffer which all charitable originations are recommended to retain by the Charity Commission.

The organisation is very proactive at identifying funding opportunities, having secured donations from the Hammond Memorial Hall Trust and the Stubbington Fayre Committee. As a result of this positive approach, the Project has not needed to apply to the Council's Youth Activities Fund to cover a shortfall in financing their open access provision.

Ward Councillors, Councillor Wood and Councillor Heneghan are both strongly supportive of this application.
