# 14. Appointments to Outside Bodies

### (1) Eastern Solent Coastal Partnership

Fareham Borough Council has recently entered into a partnership agreement with Portsmouth City Council, Gosport Borough Council and Havant Borough Council to deliver a Shared Coastal Defence Management Service for the Eastern Solent area.

The purpose of this Eastern Solent Coastal Partnership is to survey and carry out research relating to coast protection and sea defence. It will also design, arrange and supervise coastal protection works. A major task is the production of Shoreline Management Plans, Flood and Coastal Erosion Risk Management Strategies and Beach Management Plans to provide the framework within which maintenance works and new schemes are identified and prioritised.

The terms of agreement for the Member Board include the following:-

The Joint Member Shared Coastal Defence Management Service Board consists of one member of each partnership Council who will act in an advisory capacity. The Board shall meet at least two times a year or more frequently if required.

The Joint Member Shared Coastal Defence Management Service Board meetings will be chaired by one of the member representatives, with the chairman role changing between the Councils on an annual basis unless otherwise agreed by the Board; the chairman role will initially be a PCC member, followed by GBC then FBC and then HBC.

The Council is asked to appoint a representative on the Joint Member Shared Coastal Defence Management Service Board which will assist with the governance of the Eastern Solent Coastal Partnership.

# (2) Highlands Hub Management Committee

The Council has been invited to appoint a representative to the Highlands Hub Management Committee

#### 15. Governance Arrangements

The Council is advised of the flexibility that the Localism Act 2011 has given local authorities to choose their own governance arrangements. The Council must decide whether it wishes to change its governance arrangements from one of Executive Leader and Cabinet (Executive) to a committee system or other arrangement, as permitted by the Secretary of State (report <a href="cl-120621-r01">cl-120621-r01</a> refers).

#### 16. Standards Arrangements

The Council is reminded that the Localism Act 2011 implemented significant changes to the Standards regime and established a new category of Independent Person(s) whose views must be sought before a decision is made

on an alleged breach of the Code or of a complaint against an elected Member. This change will result in the current three co-opted Independent Members who sit on the Standards Committee, ceasing to hold office. This report sets out the position relating to the selection and appointment of 2 new Independent Person(s). Report attached (<u>cl-120621-r03-lus</u>).
