#### **Purpose:**

This report presents an application for funding under the Council's Community Fund Programme.

#### **Executive summary:**

Generation 2 Table Tennis Club has requested funding of £2,360 for the purchase of 4 table tennis tables and associated equipment.

Generation 2 Table Tennis Club are classed as a 4 star club within the National Governing body (ETTA), are based within Neville Lovett Community School and have been established for 40 years. They provide playing, coaching, development and competition opportunities for table tennis players of all ages, levels and abilities.

Generation 2 Table Tennis Club has, over the last few years, seen a growth in membership and are foreseeing further growth within the sport. An integral part of membership growth will be a higher demand on equipment and 'table time'. The club will be paying for training to up-skill their coaches. The additional 4 table tennis tables and associated nets and posts will help with the current influx of membership and take account of future growth.

Both Councillors Steadman and Howard are supportive of this bid.

#### **Purpose:**

This report presents an application for funding under the Council's Community Fund Programme.

#### **Executive summary:**

Mr Robert Clements, Neighbourhood Watch Co-ordinator for The Meadows Estates has requested funding of £420 to pay for new hedging and shrub clearance at Bridleway 100/101.

As part of a health & safety improvement, local residents wish to lay a small 20m Hawthorne hedge along Bridleway 100/101 and undertake clearing of scrub. This will open the Bridleway up creating a more open and secure environmental for users.

As the Bridleway is not owned by the Council, permission for the works has been sought and granted from Hampshire County Council as the owners of Bridleway 100/10.

A quote for the work has been received by Mr Robert Clements and the bid is for £420.

Councillor Steadman as Chairman of Fareham CATs and Councillors Trott and Whittle are all supportive of the bid.
