1. APOLOGIES FOR ABSENCE

Apologies for absence were received from the Chairman, Councillor Mrs P M Bryant and from Councillors T J Howard and D J Norris.

2. MINUTES

RESOLVED that the minutes of the meeting of the Licensing and Regulatory Affairs Committee held on 8 July 2014 be confirmed and signed as a correct record.

5. **DEPUTATIONS**

There were no deputations made at this meeting.

DECISIONS UNDER DELEGATED POWERS

6. REVIEW OF POLLING DISTRICTS AND POLLING PLACES

Councillors Mrs Mandry (Crofton Youth Centre), Miss Bell (Portchester Community Centre) and Ford (Victory Hall) all declared personal non-pecuniary interest in this item, indicating that they had connections with the management committees of the buildings in which the polling stations shown were located. Councillor Price declared that he was a member of Hampshire

Fire and Rescue Authority but that all administrative responsibility concerning the use of Fareham Fire Station and Portchester Fire Station as polling stations lay with Hampshire Fire and Rescue Service.

The Committee considered a report by the Director of Finance and Resources on the review of polling districts and polling places.

RESOLVED that:-

- (a) a draft proposal, based on the comments in Appendix A, be approved to proceed for consultation;
- (b) it be noted that the results of the consultation would be reported to the next meeting of the Committee; and
- (c) the officers be requested to note the comments relating to: the use of Harrison Primary School; a possible change to the polling station for Craigbank Court; the possibility of a polling station being located at the new Collingwood Court; car parking at the Locks Heath District Centre; the relative suitability of Portchester Parish Hall and the Castle Street Centre; possible alternative polling stations for residents of Brook Lane; access to Wicor Primary School and general suitability of polling stations in the ward; the suitability of Crofton Youth Club and Crofton Community Centre; and the use of a Portakabin as a polling station.

7. RESPONSE TO DEPUTATION TO COUNCIL

The Committee considered a report by the Director of Community on a matter raised in a deputation to the Council meeting on 24 July 2014, which was referred to the Licensing Officers for consideration. It was noted that Mr Rogerson, who had made the deputation at the Council meeting, had sent an e-mail to members of the Committee concerning the report it had before it.

Subject: STATUTORY REVIEW OF POLLING DISTRICTS AND POLLING

PLACES - FINAL PROPOSALS

SUMMARY

The Council has a statutory duty to undertake a review of polling districts and polling places before 31 January 2015. At its last meeting the Committee approved a draft scheme for consultation. The Committee is now asked to review the outcome of the consultation and to recommend a final scheme for adoption.

RECOMMENDATION

The Committee is recommended:

- (a) To consider the further comments made on the review of polling districts and polling places as a result of the consultation on the draft scheme and to consider the recommendations as set out in Appendix A;
- (b) Subject to the outcome of consideration of Appendix A, to review the proposed final scheme as set out in Appendix B;
- (c) To recommend to Council the final scheme for adoption for the next four years.

INTRODUCTION

- The Committee is reminded that, as reported at the last meeting, the Council has a statutory duty to keep under review the polling districts and polling places it uses for parliamentary (and other) elections. The last review was undertaken in 2011 and Regulations require that this review be concluded before 31 January 2015.
- 2. This report includes the further comments received as a result of consultation on the draft scheme and includes recommendations in response to those further comments. The Committee is asked to determine the final scheme, with a view to recommending it to Council for adoption for the next four years.

THE LEGISLATIVE BACKGROUND

- 3. The legislative background to undertaking reviews of polling districts and places was set out in detail in the previous report to the Committee in September. The essential elements to be borne in mind are:-
 - (i) that the area is to be divided into polling districts;
 - (ii) that a polling place (a building or an area) must be designated for each polling district for the location of polling stations during an election;
 - (iii) that electors have reasonable facilities for voting as are practicable in the circumstances:
 - (iv) that so far as is practicable every polling place is accessible to electors who are disabled; and
 - (v) that interested parties are consulted, especially those with an interest in ensuring accessibility to disabled persons.
- 4. If the local authority in carrying out a review fails to meet the reasonable requirements of the electors or does not take sufficient account of the accessibility to disabled persons of polling stations within a designated polling place, then representations may be made to the Electoral Commission. The Commission may then direct the authority to make alterations to the polling places designated in the review.

CONSULTATION ON THE DRAFT SCHEME

5. Preliminary consultation had been carried out in drawing up initial proposals and at its last meeting the Committee approved a draft scheme for further consultation.

Those further comments and suggested amendments received are set out in Appendix A. Recommendations in response to those comments and suggestions are included for members to approve or otherwise determine.

THE FINAL SCHEME

6. A final scheme has been drafted, based on the proposals in the draft scheme modified as a result of the comments and suggestions made during the recent round of consultation. The position relating to a number of polling stations

remains to be determined and an update will be available at the meeting, but otherwise the proposed final scheme assumes all the remaining recommendations made in Appendix A are approved.

7. The proposed final scheme is set out in Appendix B. Members are asked to consider the proposal, with a view to recommending it to Council for adoption, subject to determining any updates brought to the Committee and to any further amendment the Committee may make.

RISK ASSESSMENT

8. The Committee is reminded that undertaking this review fulfils the Council's statutory obligations. However, failure to meet the reasonable requirements of electors or not taking sufficient account of accessibility to disabled persons may lead to representations to the Electoral Commission, which may direct changes to be made. In undertaking the review the Council is ensuring that it is taking reasonable steps to enable all electors to participate in the democratic process.

CONCLUSION

9. The Council has a statutory duty to undertake a review of the polling districts and polling places used in parliamentary (and other) elections before 31 January 2015. The proposals for the final scheme set out in Appendix B to this report have been formed following consultation on the draft scheme approved by the Committee at its last meeting. The scheme takes account of the comments of statutory and other consultees and has regard for housing developments in the next four years, when a further review will be undertaken. The views of accessibility groups have been taken into account and, where additional comments have been made on operational practice, these will be passed to the relevant Returning Officer for action. The Committee is asked to approve a final scheme and recommend it to Council for adoption.

Subject: REVIEW OF HACKNEY CARRIAGE FARES

SUMMARY

Each year the views of the taxi trade are sought in respect of whether they wish the Council to consider an increase to the taxi tariff. The last time the trade indicated they wanted a tariff increase was in 2008, and the matter was considered by the Committee at that time and an increase was granted. In July this year a newsletter was sent to the taxi trade, which sought their view on whether they wished to have an increase to the taxi tariff. There were 4 individual responses from the trade that indicated that they wanted the tariff increased.

RECOMMENDATION

The Committee is requested to consider the responses from the trade in respect of the level of tariff and consider if an increase is appropriate and make a recommendation to the Executive in respect of the level of taxi tariff.

INTRODUCTION

- 1. Each year the taxi trade are consulted in respect of the level of taxi tariff. The last time the trade indicated they wanted a tariff increase following consultation was in 2008, and the matter was considered by the Committee at that time and an increase was granted.
- 2. In July this year a newsletter was sent to the taxi trade (this can be seen as Appendix A) to consult upon the taxi tariff. There were 4 individual responses from the trade that indicated that they wanted the tariff increased; these responses can be seen as Appendix B. Response 2 represents 75 licensed vehicles.
- 3. One of the responses raises the issue of charges for credit card payments, as the payment provider passes on a charge to the driver/vehicle owner in each case. The charges may vary from provider to provider. Legally the payment recipient cannot charge an additional fee higher than that charged to them. Some drivers add this charge to their fare, although strictly speaking this isn't currently allowed as it is not covered by the tariff. Members may wish to consider this matter also at this time, should they wish to amend the tariff.
- 4. There are currently 224 Hackney Carriage vehicles licensed in the Borough, 185 licensed Hackney Carriage drivers and 77 Dual Licensed Drivers.

INDICES

5. Since the last tariff increase in September 2008, average earnings have remained fairly static, whilst motoring and other travel costs have increased significantly. Inflation is currently around 1.2% and has varied between 1% and 4% year on year since 2008.

RECOMMENDATION

6. Members are asked to review the fares comparison spread sheet (Appendix C) and consider whether to recommend an increase in the tariff. Also included in Appendix C are some example increases in order to further assist members

CONCLUSION

7. That members consider the information contained in the report when making their decision regarding the level of Fareham Taxi Tariff.

Tariff

We have not received any requests for a tariff change this year. Please contact us within one week of receiving this newsletter if you would like the Members to consider a change to the tariff.

Rank Etiquette

Please remember that when you are on the rank passengers should be directed to the front of the rank. Whilst the public can choose which vehicle/driver they want to use, casual people who turn up at the back or middle of the rank should be told where the front of the rank is. We have had reports recently that drivers are not doing this and it is causing bad feeling. If we get repeated complaints about particular drivers we will consider taking them to Panel.

Passenger Numbers

Just a reminder, the number of passengers you are licensed for is the number you can take. It does not matter if an additional passenger is a baby in arms, they cannot be carried. A good way to remember this is heartbeats, ie if it is human and has a heartbeat it counts as a passenger.

Abolition of the Tax Disc

From 1 October 2014, the paper tax disc will no longer be issued and required to be displayed on a vehicle windscreen. Vehicle tax will still need to be paid but with DVLA having a digital record of who has and has not paid, a paper tax disc is no longer necessary as proof that vehicle tax is paid. The vast majority of motorists pay their vehicle tax with latest figures confirming that over 99% of motorists' tax their vehicles on time. Most on-road enforcement action is now based on using Automatic Number Plate Readers. These cameras use the number plate rather than a visual inspection of the tax disc. The police also have access to DVLA records via the police national computer. There are significant savings for fleet operators and other businesses from not having to handle the administration of tax discs.

Response 1

A number of Council Licencing Departments throughout England have made a statement on their tariff card concerning the payment that Hackney Carriage Drivers or Companies will add to the fare to cover additional expenses incurred by accepting card payments. Locally Southampton, Portsmouth and the Isle of Wight have adjusted their tariff card. The problem is that the cost to the driver or company varies so to put a specific amount or percentage on the tariff card might not cover the costs for everyone.

Would you be kind enough to confirm the need for an additional statement on the Tariff Card?

If needed could the statement be generalised rather than specific, for example, the same statement as Southampton City Council, which is

'CARD PAYMENT – If payment is made by credit or debit card, a sum not exceeding that permitted by law shall be added to the fare' **or**

'CARD PAYMENT - Additional charges may be made in accordance with The Consumer Rights (Payment Surcharge) Regulations 2012'.

Some of the Associations members are convinced that a statement is required to keep the trade acting legally.

Response 2

As per your recent newsletter I request the following alterations to the tariff :-

- 1. Pull off Charge to be increased to £2.40 for 1st 190 meters.
- 2. Scrapping of the 10p charge for dogs other than assistance dogs.
- 3. Additional Charge for pick ups from Fareham Station to be increased to £1.00.
- 4. Charge for extra passengers over 2 increase to 50p for each additional person.
- 5. Charge for items of luggage (not shopping bags) carried outside the passenger area to be increased to 50p per item.
- 6. Additional item added to Tariff "Card payment If payment is made by credit or debit card, a sum not exceeding that permitted by law shall be added to the fare"
- 7. Soiling Charge Maximum of £50.

All other charges to remain the same.

In order to justify the above & in my capacity as Managing Director of Radio Taxis (Fareham) who operate in excess of 75 Hackney Carriages in Fareham I would like to make the following observations.

When we had the last large tariff increase in 2008 Radio Taxis suffered a significant loss of business in 2009. Part of this could be put down to the start of the recession, however we believe the major detrimental effect on our business was due to the large tariff increase in 2008. Smaller annual or every other year increases would be more acceptable to customers and have less effect on your business. (nobody notices 2/3p on a loaf of bread/pint of milk but a large 20p increase would be noticed by a large number of people)

A 20p increase on the pull off charge would take account of inflation over the last six years and would bring us in to line with both Gosport and Portsmouth at £5.60 for 2 miles. (we are at present at £5.40 as detailed in the July issue of PHTM, which I can supply you a copy if you wish, this lists all Hackney Tariffs in England and Wales)

Very few taxis charge 10p for dogs - if they indeed take them. (We are bound by law to take assistance dogs for which there is no charge) it seems a rather trivial amount to bother with and should be removed. Note neither Portsmouth or Southampton have this charge.

Fareham Station Pass was £239 in 2010 (was around £200 in 2008) - for 2014 it was £311 !! So has increased by 55% - 60p to £1 would just cover this.

10p per extra passenger over two, it has been this for donkeys years - with the extra wear & tear carrying 4 people on Saloon Cars 50p is justified - this would also help the multi-seaters out with their significantly higher running costs.

10p per item of luggage - same as above in terms of time it has existed - but 50p per item only to be charged for items of luggage in the boot/hatch area. n

No Charge for shopping bags. (Note 50p is only a half a cup of tea these days or a third of a cup of coffee!)

More and more customers want to pay by credit/debit card this wording covers any Government laws that may be passed in the future.

Soiling Charge increase takes account of inflation between 2008-2014.

These are obviously the maximum fares allowable - if certain parts of the taxi trade in Fareham do not want increases they are quite at liberty to continue charging the old tariff as it is would be less than the new charges.

Response 3

I would like the trade to consider a tariff increase for this year!

Response 4

we would like to confirm in writing that we believe there should be an increase in taxi fares this year.

Our reasons for this are twofold. Firstly the cost of fuel and living has gone up since fares were last raised, and secondly we are concerned that there will be a repeat of what happened last time - namely that we held off for so long that when rates were finally raised it was by such a large amount that it came as a shock to customers and hit them hard and therefore use of taxis was reduced as a result. In our opinion it would be preferable to raise rates regularly but by small amounts. We believe the ideal amount to raise fares at the moment would be between 2 and 3 per cent to match the increase in the cost of living over the last year.

Subject: SPENDING PLANS 2015-16

SUMMARY

This report sets out the overall level of revenue spending on this Committee's services and seeks approval for the revised revenue budget for 2014/15 and the base budget for 2015/16.

RECOMMENDATION

- (a) That the revised budget for 2014/15 be approved;
- (b) That the fees and charges for 2015/16 be approved; and
- (c) That the base budget for 2015/16 be approved.

INTRODUCTION

- 1. The Council has a co-ordinated strategic, service and financial planning process and this report allows the Committee to consider in detail these plans for the provision of Licensing and Regulatory Affairs services during the next financial year.
- 2. This report and the revenue budgets have been prepared in accordance with the Medium Term Finance Strategy that was approved by the Executive on 6 October 2014 and will cover the capital programme, fees and charges and the revenue budget.

CAPITAL PROGRAMME

3. For this Committee there are no capital projects planned.

FEES AND CHARGES

- 4. The current fees and charges for Licensing and Regulatory Affairs services and the proposed charges for 2015/16 are set out in Appendix A.
- 5. The proposed discretionary charges have been reviewed to move towards a consistent charging basis being applied across the Environmental Health Partnership wherever possible and where there will be no significant effect on income. The reduction in the charge for Skin Piercers is an example of this so there is consistency between the two authorities.
- 6. The charge for Dangerous Wild Animals has reduced to reflect the small administration time in providing these licences as the bulk of the charge would be for vet's fees which are additional to the licence.
- 7. The charge for tables and chairs has been included to formalise and standardise current charges being applied but not published.
- 8. There is no proposal to increase the fees for taxi licensing as with the recent employees' structure changes, it is too early for the actual cost of the service to be known. In addition the Council has made efficiencies in the way the service is delivered enabling the current charges to be maintained at existing levels, while still fully funding the service. This will be the sixth successive year where there has been no increase; the last increase in fees was in April 2009.
- 9. It is proposed that the hourly charge for technical advice to businesses for Licensing and Health and Safety advice should not be increased this year as this fee is still considered to be a fair reflection of the actual cost to provide the service and remains in line with the other technical advice charges in the Public Protection portfolio.
- 10. Members may also wish to consider whether, for certain services, there could be scope to generate additional income to pay for service improvements.

REVENUE BUDGET

11. Appendix B analyses the overall budget total over the individual Licensing and Regulatory Affairs Committee services and by the different types of expenditure and income.

Base Budget 2014/15

- 12. The base budgets for 2014/15 were considered by this Committee in November 2013 and were confirmed by the Full Council on 21 February 2014.
- 13. The base budget for 2014/15 amounted to £503,400.

Revised Budget 2014/15

14. The overall revised budget for 2014/15 is £497,200, a decrease of £6,200 or 1% from the base budget.

Base Budget 2015/16

15. The overall base budget for 2015/16 is £477,500, a decrease of £25,900 or 5% from the base budget for 2014/15.

17. Appendix B of this report shows the analysis of expenditure and income for individual services and the following paragraphs of this report set out issues affecting individual services that have arisen in the current year in order to explain the variations between the base and revised budgets for 2014/15 and the base budget for 2015/16.

SERVICE ISSUES

Environmental Health Partnership

18. From 1 April 2014 the Environmental Health service has been provided by way of a Partnership between Fareham and Gosport Councils in order to provide a more resilient service and to bring savings to both Councils under the control of the Environmental Health Panel.

- 19. Under this arrangement, the direct costs for the service have been combined into a single Trading Account. This is where expenditure under the headings of employees, premises, supplies and services and third party payments incurred by the Partnership are recorded, and recharged to both Fareham and Gosport Councils on the basis of a 50: 50 split.
- 20. The apportionment of this recharge to Fareham is recorded as a third party payment in the individual service areas. It is based on time allocations of Fareham Borough Council staff, with an informed review of these to be undertaken at the end of the first full year of the new staffing structure and working arrangements.
- 21. Support services and income attributable to Fareham and Gosport Councils are recorded directly in the respective service areas of the two local authorities.

Hackney Carriage Licences

- 22. There has been an increase in the budget for this service of £1,000. Support services have decreased by £12,100 offsetting the increase of £13,100 within third party payments.
- 23. Although this heading shows a small surplus of income over expenditure it does not reflect the cost of providing member support to this committee. This cost is shown within the Executive's Policy and Resources Portfolio and has a cost for the whole council of over £1million in the base budget for 2015/16.

Licensing

24. There has been a slight decrease in the budget for this service of £3,200. Support services have decreased by £14,300 offsetting the small increase of £11,100 within third party payments. No changes have been proposed for income from fees & charges.

Health & Safety

25. There has been an overall decrease in the budget for this service of £3,200. Support services have decreased by £20,600, offsetting the increase of £17,400 within third party payments.

Election Services

26. There has been an overall decrease in the budget for this service of £20,500. This is primarily as a result of a decrease increases in support services of £19,300 and a reduction in employee costs of £1,200.

RISK ASSESSMENT

27. There are no significant risk considerations in relation to this report.

CONCLUSION

- 28. A number of Licensing and Regulatory Affairs services are partly funded from fees and charges and other types of income. After taking service income into account, the following sources of income reduce the overall cost of services to be met by council tax payers:
 - Investment income;
 - General government grant; and
 - The Council's share of business rate income.
- 29. These sources of income are generally outside the Council's control and do not reflect changes in the overall level of spending on local services. With these sources of income effectively "fixed", members need to be aware that, unless it can be matched by increased service income, additional spending on services has to be fully funded by council tax payers.
- 30. It follows that members must give full weight to the Council's overall position and future council tax levels when the revenue budgets for 2015/16 are considered.
- 31. The Committee is asked to review the revised budgets for 2014/15 and the base budgets and fees and charges for 2015/16 and consider whether it wishes to submit comments for consideration by Full Council.

The service is provided to ensure public safety through the licensing of regulated activities and to ensure that they are undertaken in accordance with the relevant licence conditions.

In addition the Council is the Licensing Authority under the Licensing Act 2003. The Act replaced previous licensing regimes concerning the sale of alcohol, public entertainment, theatres, cinemas and late night refreshment with a unified system of regulation. From February 2005 the Council has dealt with applications for premises and personal licences which took effect in November 2005. From this date the Council took over all the licensing functions some of which, such as liquor licensing, were previously undertaken by the Magistrates' Court.

The Act requires that the Council carries out its various licensing functions so as to promote the following four licensing objectives:-

- The prevention of crime and disorder
- Public Safety
- The prevention of public nuisance
- The protection of children from harm.

The Fees have been set by the Government and are detailed below:
