**Purpose:**

This report presents an application for funding under the Council's Community Fund Programme.

**Executive summary:**

An application for funding has been received from Mrs Pam Formby on behalf of Bursledon Brickworks Museum.

The application seeks the sum of £500 towards the cost of establishing a Local History Group for Swanwick, Sarisbury & BurrIDGE. The application explains that one meeting has already taken place at the museum and quite a lot of interested people attended. It is hoped that a permanent group with regular meetings at the museum would run for local history enthusiasts. The sum sought is 50% of the estimated total cost of setting up the group of £1,000 with the remaining funds being awarded from Councillor Woodward's County Councillor Grant Scheme.

Both Cllr Woodward & Cllr Swanbrow have commented on the application to give their full support.
