Executive summary:

Barrie Becheley, Chairman of Burrige AFC has applied for £2,565.60 to purchase portable dugouts. The full cost of the dugouts is £4,565.60.

The dugouts will ensure that criminal damage can be avoided as they can be moved to a safe place after use. The football club are integral to the community and have youth and adult teams.

Councillor Seán Woodward has provided £2,000 towards this project from his County Councillor grant, therefore the club are requesting the shortfall £2,565.60 from the Community Fund.

Western Wards CAT Chairman and Madam Mayor, Councillor Mrs Susan Bayford supports the bid. Executive Leader, Councillor Seán Woodward and Councillor David Swanbrow also support the bid.

Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

Executive summary:

Mary Nadolski from Warsash Victory Hall Management Committee has requested the sum of £2,444.80 to purchase two new Falcon G31016 Burner Ovens and have them installed professionally at the venue.

Warsash Victory Hall is an important venue within Warsash and continues to offer an excellent service to the community. 20 clubs use the premises each week and it is also used to host parties, weddings, concerts and jumbles sales. The purchase of these 2 ovens will allow the hall to continue this service and offer the groups using the venue quality kitchen facilities and adhere to current safety standards.

Each oven costs £1,228 and installation for the two comes to £600. The total project cost is £3,056. Both Ward Councillors have requested that Warsash Victory Hall contribute 20% towards the project, therefore the grant request is for the sum of £2,444.80. The balance of £611.20 has been raised by users of the hall to finance the total project.

Madam Mayor, Councillor Mrs. Susan Bayford, Chairman of the Western Wards Community Action Team meeting supports the bid, as do both Ward Councillors; Cllr. Trevor Cartwright and Cllr. Mike Ford.

Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

Executive summary:

Pauline Griffiths from Locks Heath Free Church has applied for £3,500 to purchase a new electric range cooker.

The Church has 700 visitors each week and hosts a luncheon club, a senior's club, a men's breakfast club, a messy church club, a summer holiday club and a teenage club, amongst their range of community activities. The Church is integral to the local community and would benefit from the purchase of a new cooker.

The electric range cooker and an upgrade to the electricity supply costs £5,035.60. The Church has raised £1,535.60 towards the proposed project leaving £3,500 which is requested from the Community Fund.

Councillor Miss Tiffany Harper, the Titchfield Community Action Team Chairman supports the bid. Councillor Jack Englefield and Councillor Mrs Sarah Pankhurst support the bid.

Recommendation:

That the application for £3,500 from Fareham Borough Council's Community Funding Programme, submitted by Locks Heath Free Church to purchase an electric range cooker be approved, subject to the applicant entering into a Community Use Agreement with Fareham Borough Council.
