#### **Executive Summary:**

Jane Gillespie of Portchester Community Centre Ltd has requested £3,838.50 for the purchase of kitchen equipment to be used at the community centre.

The proposal is to use the funds to purchase equipment such as plates, cups, saucers, utensils and other such items which would be made available for use at functions held at the centre and by all members of the community using the building.

All ward councillors for Portchester East and Portchester West were given the opportunity to comment on the application and all have given their support to the proposed funding. Councillor Bell declared that she is the Chairman of the Management Committee for the community centre. Councillor Price added that he would have thought the community centre should be prepared to part fund some part of the purchase (for example £500).

#### Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

#### Executive Summary:

An application for funding of £4999 has been received from Mr Clive Dakin of the Seafarers Sailing Club to purchase 3 replacement novice sailing dinghies.

The club is non-profit making and was formed to encourage the sport of dinghy sailing. The club is open to all and has approximately 130 paying members, the majority of which have family membership, making the numbers using the club's facilities nearer 200 people.

The club has provided a first experience sailing opportunity at the last two Access All Areas events and is keen to encourage new and novice sailors to develop their sailing skills and build their confidence.

The club would like to apply for funding of £4999 with the total project costing  $\pm 10,000$ .

CAT Chairman, Councillor Mandry is supportive of the bid as is Councillor Knight.

#### Recommendation:
