Supporting Information

Background

- 1. Serpentine Road is a residential street lying to the north of Fareham town centre, and is included in the residents parking zone.
- 2. Outside No 74, a single car length of residents parking bay was provided, with a prohibition of waiting between 10am and 4pm (Mon-Fri) either side of this bay. This was the most appropriate restriction when the scheme was introduced in 2010, but the present occupiers of this house have now sought to have a dropped vehicular crossing provided to enable them to park off the road.
- 3. This is acceptable in traffic management terms as it helps to keep the road clearer for the passage of traffic, but it means that parking in this bay by any other residents in possession of permits would block the new access point.
- 4. The householders have asked for the restrictions to be changed to match those which exist on either side of their frontage.

Consultations

- 5. The Police, Ward and County Councillors have been consulted on this proposal and expressed their support.
- 6. The Statutory Consultees were consulted and no objections were received.


Representations
