Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

Executive Summary:

An application for community funding has been received from Mr Adrian Smith, Scout Leader of 1st Sarisbury Green Scout Group, for the sum of £750.00 to use towards the purchase of a marquee for the group.

1st Sarisbury Green Scout Group is a heavily subscribed unit based at Burridge Village Hall.

The 1st Sarisbury beavers, cubs and scouts go on group camps many times during the year, with approximately 60 children plus adults in attendance at each camp. The group currently has sufficient tents for all of the children to sleep in; however they do not have anything large enough to use for feeding, entertaining or for storing kit in the event of bad weather. They would therefore like to purchase a marquee for use at the regular group camps.

Financial reserves are limited, as the group is currently saving towards the cost of a new scout hut. The total cost of the marquee is £1580.00 and the group have applied to the Hampshire County Councillor grants fund for £750.00. They are therefore applying to the community fund for £750.00 and will pay the remaining £80.00 from their own funds. If approved, the £750.00 community fund award will only be released if the Hampshire County Councillor grant application is successful.

Councillor Swanbrow and Councillor Woodward are in support of this application.

Recommendation:

That the application for £750.00 from Fareham Borough Council's Community Funding Programme, submitted by Mr Smith of 1st Sarisbury Green Scout Group to use towards the purchase of a marquee, be approved.

Purpose:

This report presents an application for funding under the Council's Community Fund Programme.

Executive Summary:

An application for community funding has been received from Mrs Sheila Simpson, Treasurer of Stubbington University of the Third Age (U3A), for the sum of £500.00 to use towards the purchase of audio and visual equipment.

The U3A is a national, not-for-profit, self-help organisation for retired and semi-retired people, providing educational, creative and leisure opportunities in a friendly environment. The U3A offers the opportunity for people to share their knowledge, experience and talents with others whilst also providing the chance to learn new skills themselves.

The Stubbington U3A division has been running since March 2015 and currently has over 300 members. Monthly meetings are held at Holy Rood Church Centre in Stubbington and they have also started up over 40 groups that meet regularly, including bird watching, computing, genealogy, gardening, photography and walking.

The group would like to purchase equipment including a laptop, projector and speakers for use at their meetings. This equipment will enhance their monthly meetings and assist with presentations to improve the visual and audio experience for the members. As well as being used at the monthly meetings, the equipment will also be available for members to use at their regular groups.

The total cost of the equipment is approximately £1513.00. Stubbington U3A will be contributing £1013.00 from their funds and are therefore applying to the community fund for the remaining £500.00.

Councillor Mrs Mandry and Councillor Wood are in support of this application.

Recommendation:

That the application for £500.00 from Fareham Borough Council's Community Funding Programme, submitted by Mrs Simpson of Stubbington U3A towards the purchase of audio and visual equipment, be approved.
