SUMMARY

This report advises members of the Panel of the relevant representation received from the Police regarding a Premises Licence Variation in respect of Fareham Charcoal Grill, 140 West Street, Fareham, PO16 0EL.

RECOMMENDATION

That the Panel determines the application having regard to the provisions of the Licencing Act 2003 and associated regulations, the Council's Licensing Policy and the representation received.

BACKGROUND

1. The Licensing Act 2003 specifically restricts the grounds on which the Council, as Licensing Authority (LA), may refuse an application for a New Premises Licence, or impose conditions. Where relevant representations are made, the LA may refuse on the grounds that the licensing objectives are not met or the operating schedule is inadequate. Equally, conditions may be imposed where appropriate. The LA may also refuse an application in part and thereby only permit some of the licensable activities sought.
2. The decision making committee, in considering an application, must have regard to the adopted Statement of Licensing Policy and any relevant representations made.
3. An applicant applying for a new premises licence, whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court.
4. In considering this application the Panel will sit in a quasi-judicial capacity and is thus obliged to consider applications in accordance with both the Licensing Act 2003 (Hearings) Regulations 2005, and amending secondary legislation and the rules of natural justice. The practical effect of this is that the Panel must make its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision. The Panel must also have regard to:-

Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places a Council under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

Human Rights Act 1998

The Act requires UK legislation in a manner consistent with the European Convention on Human Rights. It is unlawful for the Council to act in a way that is incompatible with the rights protected by the Act. Any action undertaken by the Council that could have an effect upon other persons' Human Rights must be no more onerous than is necessary in a democratic society. The matter set out in this report must be considered in light of the above obligations.

PROCEDURE FOR THE HEARING OF THE APPLICATION

5. The standard procedure for the hearing of this licensing application can be seen as Appendix A.

THE APPLICATION

6. This application is in respect of:-

Fareham Charcoal Grill, 140 West Street, Fareham, PO16 0EL.

The type of application is: Premises Licence Variation.

The Premises Licence Holder is Mr Jihad Haji who has held this position since March 2016.

The licence is held for Late Night Refreshment, Sunday to Wednesday 23:00 to 00:00 and Thursday to Saturday 23:00 to 02:00.

7. The variation seeks to remove Condition 3 which states:

“When the premises are open for business past midnight, 2x registered security staff shall be on duty from midnight until close. They should be easily identifiable by wearing high visibility tops.”

PROCEDURE FOR HEARINGS BY THE LICENSING PANEL

GENERAL

- 1 This procedure will be followed for hearings held by the Licensing Panel to determine :-
 - Applications for grant, variation or review of a premises licence under the provisions of the Licensing Act 2003 where representations have been made by any of the responsible authorities or interested parties (as defined by the Licensing Act 2003);
 - Applications for grant or renewal of a personal licence under the provisions of the Licensing Act 2003 where representations have been made by any of the responsible authorities or interested parties (as defined by the Licensing Act 2003);
 - Applications for grant or renewal of a public entertainments licence which is not otherwise determined by officers;
 - Such other licensing matter as may be referred by the Licensing Officer or the Licensing and Regulatory Affairs Committee from time to time.
- 2 Hearings shall be held in public unless the Panel considers that the greater public interest is served by excluding the public from the meeting in accordance with Schedule 12A of the Local Government Act 1972. Circumstances when it may be appropriate to do so include where there is a likelihood of disclosing exempt information relating to the applicant.
- 3 Parties to the hearing will be the applicant and any responsible authority or other interested party making representations. The parties to the hearing may be accompanied by a representative, who may present the case on their behalf.
- 4 The Licensing Officer will not be a party to the hearing but will facilitate proceedings by conducting such pre-decision discussions as may be required and by presenting at the hearing a summary report of the application and any representations, together with the Officer's comments as to how these relate to the relevant legislation and the appropriate licensing policy.
- 5 Where any party intends to produce documents in support of his/her case they shall have been asked to do so in advance of the date of hearing. In the event that a document is submitted for consideration for the first time at the hearing, the Chairman may adjourn the hearing to a later time or date. It is expected that such adjournments will only be used in exceptional circumstances. The Chairman may in any event adjourn the hearing at any time before the Panel reaches its decision for any other reason he/she considers appropriate.
- 6 Each party when asked will present details of any witnesses to be called.

AT A HEARING in accordance with THE LICENSING ACT 2003

- 1 **The Chairman of the Licensing Panel** will outline the procedure to be observed and may invite interested parties¹ to appoint a spokesperson².
- 2 **The Chairman** will ask the applicant whether any modification is to be made to the application or operating schedule submitted.
- 3 **The Licensing Officer** will present a summary of the application and of any representations received and will comment upon their relevance to the Licensing Act 2003 and the Council's licensing policy.
- 4 **The Applicant** may comment on the application and on representations made addressing the four licensing objectives³.
- 5 **The Panel** may seek clarification of points.
- 6 **The responsible authorities** in turn shall make their representations relating to one or more of the licensing objectives³ and may be questioned by members of the Licensing Panel and/or applicant.
- 7 **Interested parties**¹ in turn shall make their representations relating to one or more of the licensing objectives³ and may be questioned by members of the Licensing Panel and/or applicant.
- 8 **The responsible authorities** in turn may make a closing statement.
- 9 **The interested parties** in turn may make a closing statement.
- 10 **The Applicant** may make a closing statement.
- 11 **The Licensing Panel** will then withdraw from the hearing to deliberate in private. In the event of uncertainty on any of the evidence, all parties will be recalled to the hearing whilst the point in question is clarified. In the event that the Licensing Panel has sought advice on points of law, the legal adviser shall explain to all parties what advice was given.
- 12 **All parties** shall be invited to return to the hearing when the Licensing Panel has completed its deliberations.
- 13 **The Chairman** shall announce the Panel's decision.

¹ : ie those living or running a business in the area who have submitted representations;

² : this is most likely where there are a number of persons making representations upon the same point. The fact that the Panel does not hear from all interested parties will not mean that their representations are not taken into account, but rather that the strength of feeling is understood and the case will not gain weight through repetition;

3. the four licensing objectives are:- (i) The prevention of crime and disorder; (ii) Public Safety; (iii) The prevention of public nuisance; (iv) The protection of children from harm.

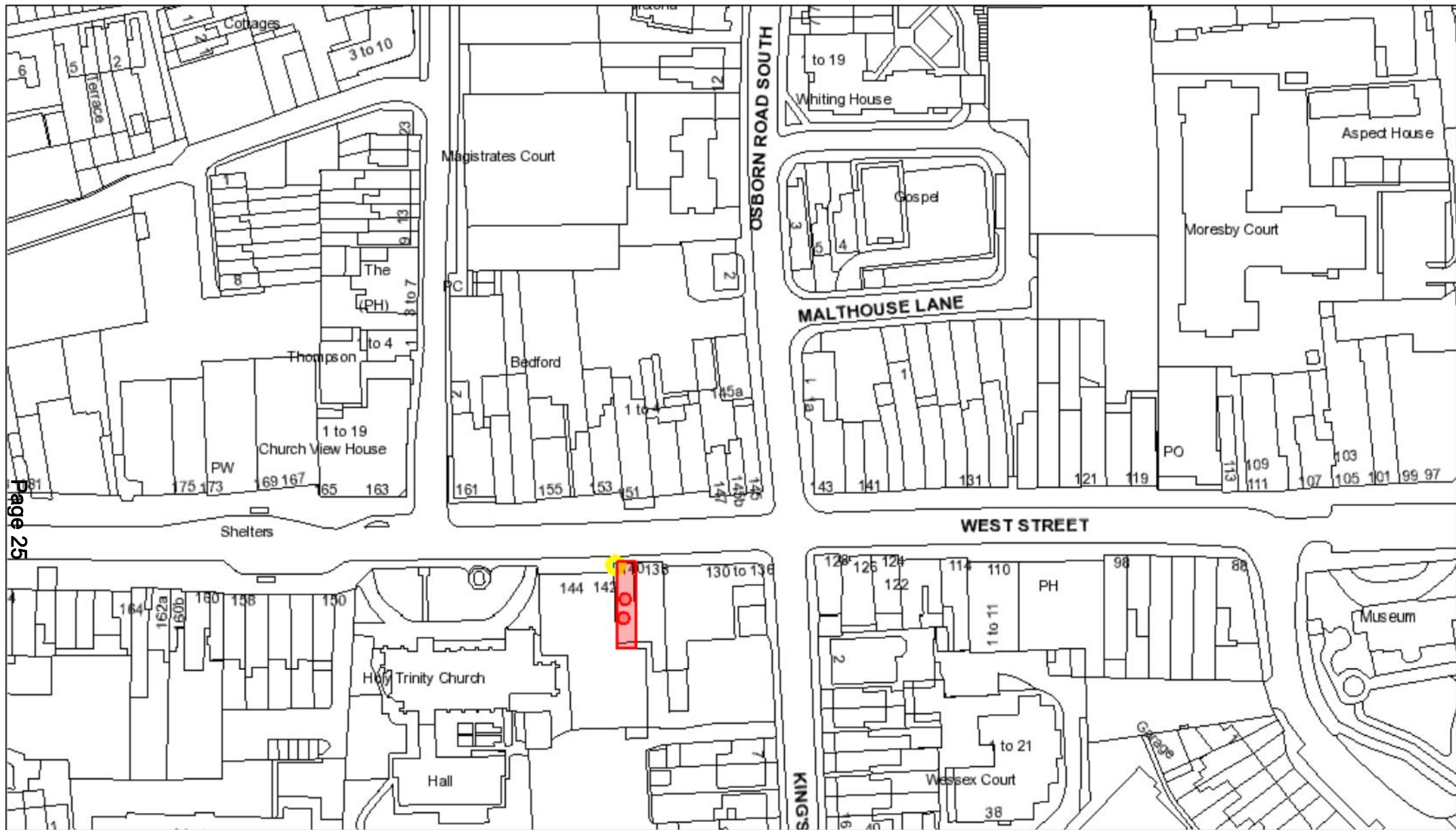

Hampshire Police wish to make a representation regarding the application to vary the premises licence at Charcoal Grill, 140 West Street, Fareham on 1st October 2016.

The variation seeks to take away the condition requiring security staff to be present at the premises when trading past midnight.

This condition was originally added to the premises licence when it was subject to a review hearing brought by the Police in 2010. This was due to significant associated violence, crime and disorder. The review hearing resulted in the licensing sub-committee cutting back the hours of trading from 0300 to 0100 and a condition added to the premises licence to require 2 x security staff to be present from midnight until close. (see annexe 1 review application document).

Charcoal Grill sits within Fareham town in close proximity to a number of pubs and therefore benefits from customers leaving these pubs. Therefore a proportion of customers will be intoxicated.

In 2015 a variation of premises licence was submitted by the premises licence holder Bayram Kabadayi to extend the opening hours from 0100 to 0230 hours on Thursday, Friday and Saturday evenings. Police were concerned that the extension would result in the problems solved by the review hearing in 2010.

Written agreement was achieved with the premises licence holder to extend the opening hours until 0200 but with conditions including:

"When the premises is open for business past midnight, 2 x registered security staff shall be on duty from midnight until close. They should be easily identifiable by wearing high visibility tops". (see annexe 2, email correspondence)

This condition remains on the premises licence to the present day.

On 02/03/2016 the premises licence was transferred from Mr Bayram KABADAYI to Mr Jinad HADI.

At this time of taking over the premises licence Mr HAJI would have been fully aware of the conditions of the premises licence that he was buying into.

The Police have visited Charcoal Grill several times over the past months and there have been no security staff on duty.

On 09/09/16 the manager of the shop Mr Adem YORULMAZ informed the Police Licensing Officer PC Pearce that he was not aware of the requirement for security staff and had worked there for several years. He was unable to produce a copy of the premises licence. PC Pearce assured him that security staff after midnight was a premises licence requirement of being open to sell hot food after 2300. Mr YORULMAZ said that it was not necessary. He was clearly missing the point as this is a legal requirement. (see annexe 3, officer working sheet on Police RMS system).

In addition to what appears to be a continual breach of an important condition of the premises licence as required by a licensing panel, there have been associated incidents of violence at the premises over the past year:

12/12/15 @ 01:35 - Male winding another up in kebab shop. Male walked outside, the other pushed him into the window causing it to smash and cause serious laceration on head. 10 stiches need - GBH injury (Police ref 44150433917).

24/12/15 @ 01:00 - 2 males and female in kebab shop having argument. One hit out and smashed mirror (Police ref 44150457034).

28/02/16 @ 01:00 - Dispute between drunk customer and staff (Police ref 44160083554)

27/06/16 @ 23:26 - 4 males fighting in kebab shop (Police ref 44160239916)

31/07/16 @ 21:55 - drunk female requesting staff to call her a taxi (Police ref 44160286287)

04/08/16 @ 23:00 - Male asking staff to 'come out and play' and threatened to shoot staff (Police ref 44160291915)

06/08/16 @ 02:00 - Male assaults male at kebab shop (Police ref 44160293329).

These are only the associated incidents over the past year that the Police have been made aware of. Several of these incidents have been after midnight.

It is the Police opinion that the incidents show there is still a need for security staff as required by the licensing panel and also that the premises should not be rewarded for continual breaches of an important requirement.

The current premises licence holder Mr HAJI took over the shop in March 2016 and would

have been aware of the conditions required to sell hot food after 2300 and only proceeded if he was willing to comply with the requirements. Consequently the security staff condition should not have been a shock to him. It appears that he has decided to ignore the requirement and in doing so has put both staff and customers at risk. It also appears that he has failed to advise staff of the requirement.

Customers from the nearby pubs, on weekend evenings in particular, are often intoxicated and therefore present greater challenges to both staff and other customers. The shop has a reasonably small public area and this can add to the likelihood of problems between intoxicated persons due to their close proximity.

Registered security staff are trained to deal with conflict and drunk persons and are therefore more likely to diffuse potential conflict and ensure that drunk or problematic customers do not get into the kebab shop.

The Police would be in agreement for 2 x SIA registered security staff to on duty from midnight until close on Friday and Saturday evenings and Chirstmas Eve / New Years Eve as these are the higher risk nights. As with the current premises licence condition these staff should be easilly identifiable wearing high visibility tops.

This Review seeks to address continuing violence and disorder at or linked to Bodrum Grill House take away.

The present Premises Licence allows the premises to both open and serve food up until midnight on Sunday to Mondays and until 0300 on Saturday and Sundays.

It is the Saturday and Sunday close time that is of concern and in need of being trimmed back to an earlier close time in order to reduce the significant related Crime and Disorder.

The Police seek to reduce the close times for both Friday and Saturday evenings from 0300 to 0030 (half past midnight).

The premises is a traditional kebab takeaway close to the town centre pubs and clubs. Inside it has a small public standing / waiting area and two tables with chairs for eating.

Bodrum kebabs has been the location of numerous incidents of violence and disorder, during the early hours (midnight – 3am) on Friday and Saturday nights.

I will list evidence over the last year of such incidents which are recorded on the Police Record Management System.

Over the past 10 months there has been no similar concentration of violent incidents at any other location in Fareham with the exception of Fareham's nightclub Chicago Rock Café, which has numerous Licence conditions in place to address the potential of violence / disorder.

It is suspected that the reason for such a high volume of incidents at this location at this time of the night / early morning, is because Bodrum Grill House has a Licence to open and sell food until 3am on Fridays and Saturdays. No other Fareham takeaway premises attracts such a level of violence and disorder, which suggests that the primary factor of the incidents is the late close time.

It is the Friday and Saturday evenings when the violence and disorder is taking place at this location and consequently these evenings that need the close times to be reduced.

It is a very reasonable conclusion to make that these incidents are occurring because drunken persons are coming from late night town centre Licensed premises to obtain food from Bodrum Grill House due to it still being open for trade.

It is simply the fact that Bodrum Kebabs is open at such a late hour that causes the intoxicated persons to gravitate to this location.

It is unfortunate that Bodrum Grill House has had so many linked incidents of violence and disorder but whilst the premises may feel aggrieved by such Review proceedings, it is simply an occupational hazard of trading at such a late hour that results in the customer base often being drunk or problematic.

It is therefore reasonable and proportionate to seek to address the issue by way of reducing the close time of the premises during the primary days and times of the Crime and Disorder.

The Police firmly believe that the only way to address the problem is to trim back the trading hours on Friday's and Saturdays. There is ample evidence to back this up. If however, the Licensing Authority Panel feel that the close times should remain, we would ask that the below additional Licence conditions are added to the Premises Licence. These are felt to be reasonable and proportionate to the violence and disorder that exists at this premises.

Prevention of Crime and Disorder

1. Recordable CCTV to be of a standard and specification agreed by Police which must be acceptable for evidential use if required. The system must record the inside and outside of the premises as per advice given by the Police Crime Prevention Officer. Imagery obtained must be retained for a minimum of 31 days on a rolling basis and must be playable on any window based computer without the need for any enhancement or additional software. The system should be working and maintained at all times. Staff must also be suitably trained to ensure that they can provide CCTV recordings to Police and Council officials upon request (this is a more robust amendment from current condition on CCTV)
2. A minimum of two (2) Security Industry Authority (SIA) registered Door Supervisors will be on duty at the premises from 0030 hours to close on Friday and Saturday evenings. Two are required to ensure there is cover for comfort breaks and Health and Safety requirements.
3. Any customer that is considered drunk or heavily intoxicated should be refused service and turned away at the door.

Public safety

4. In addition to door staff requirements, a minimum of 3 staff should be on duty at the premises between midnight and close on Friday into Saturday and Saturday into Sunday evenings. This is to ensure that food is served quickly to prevent a queue build up.

Public Nuisance

5. Clear signage informing customers to leave quietly and respect the neighbours should be placed in prominent locations particularly near to the exit door.
6. Staff should ensure that discarded rubbish from the outside of the premises and near vicinity is cleared away each evening. This would include discarded food, food containers and any vomit from customers within the close proximity of the premises.

Protection of Children from Harm

7. No children (under 18) should be allowed into the premises between 2300 and close on Fridays into Saturdays and Saturdays into Sundays.

Dear Mr Kabadayi,

I write with reference to your recent application for a extend the opening hours at Charcoal Grill kebab shop, 140 West St, Fareham. You seek to extend your hours from 1am to 2:30am on Thursday to Saturday nights.

I have looked at your application and there is nothing written in section M where you need to outline the measures you intend to put in place to uphold the 4 licensing objectives.

By opening until 2:30am, especially at weekends, will present challenges for the staff who are working at the shop.

At that time of night you are no doubt seeking to capitalise on the local people leaving pubs. Dealing with intoxicated people during these hours can be difficult and present risks to staff and other customers due to people being drunk and therefore being more likely to become involved in violence, crime and disorder.

Historically your shop has experienced regular incidents of violence when it has been open later than 1am so there is a need to have proportionate measures in place. You will be aware that in the past the Police have been caused to 'review' your premises licence and the result was a reduction of your close time from 3am to 1am.

It is for the above reasons that I have concerns about your application.

Firstly I would suggest that we agree on a 2am close, not 2:30.

Additionally for the Police to be agreement with the application your you would need to add the following conditions to your premises licence.

SECURITY

1. When the premises is open for business past midnight, 2 x registered security staff shall be on duty from midnight until close. They should be easily identifiable by wearing high visibility tops.

(This will ensure that drunks are prevented from entering the shop, staff are protected and their physical presence will reduce the risk of any trouble).

CCTV

2. The premises licence holder shall ensure that recordable CCTV is in place when licensable activity is taking place. This must be of a standard acceptable to the local Police. There shall be sufficient cameras to cover the primary public areas in addition to cameras covering the entrance / exit. Imagery obtained must be retained for a minimum of 28 days on a rolling basis. This must be made available in a format that can be viewed by Police and council officials and must be given to them on request.

3. The premises licence holder shall ensure that there are sufficient members of trained staff at the premises during operating hours to be able to provide viewable copies immediately to police on request when investigating allegations of offences or criminal activity.
