Health and Public Protection Policy Development and Review Panel

1. APOLOGIES FOR ABSENCE

There were no apologies for absence.

2. MINUTES

It was AGREED that the minutes of the Health and Public Protection Policy Development and Review Panel held on 14 November 2017 be confirmed and signed as a correct record.

3. CHAIRMAN'S ANNOUNCEMENTS

There were no Chairman's announcements.

4. DECLARATIONS OF INTEREST AND DISCLOSURES OF ADVICE OR DIRECTIONS

There were no declarations of interest made at this meeting.

5. DEPUTATIONS

There were no deputations made at this meeting.

6. POLICE CRIME PANEL UPDATE

The Panel received a verbal update from Councillor T M Cartwright, MBE, Executive Member for Health and Public Protection, on the Police Crime Panel.

Councillor Cartwright advised that the next meeting of the Police Crime Panel will take place on 26 January 2018. Topics for discussion will include plans for the new police station, the level of the policing precept for 2018/19, Central Government funding arrangements, the Police Crime Plan and the appointment of a Deputy Police Crime Commissioner.

Councillor Cartwright also reported that he attended a Working Group meeting on 15 December 2017 which reviewed the draft scope of the Police Crime Plan and discussed future topics for proactive scrutiny.

Members thanked Councillor Cartwright for providing his verbal update.

7. HEALTH UPDATE

The Panel received a verbal update from Councillor T M Cartwright, MBE, the Executive Member for Health and Public Protection, on local strategic Health issues.

Councillor Cartwright reported that he attended a meeting of the Local Clinical Commissioning Group recently where discussions took place on how the availability of appointments can be improved across the area. The CCG has a Health and Public Protection Policy Development and Review Panel

number of initiatives to explore to help achieve this and will attend local Community Action Team (CAT) meetings across the Borough to exchange information with residents and gain feedback.

Councillor Cartwright advised that there has been a significant amount of publicity for the emergency appointment system that is being trialled at the Fareham Community Hospital and he was pleased to report that the trial is going well. It is hoped that other GP surgeries in the area will join the scheme.

In response to Members' enquiries regarding the recent collapse of the Carillion group, Councillor Cartwright advised the Panel that he has received assurances from the Chief Executive of Queen Alexandra Hospital that contingency plans are in place to ensure that the hospital is able to provide a business as usual service.

Members enquired about the services that will be provided at the Welborne Health and Well-being hub and whether there is any information available as to when the services will become available. The Director of Planning and Regulation explained that the Council is working with the Fareham and Gosport Clinical Commissioning Group to develop these proposals, but that it was likely that this detail on service provision may only be forthcoming as part of a future Reserved Matters Planning Application.

Councillor Cartwright was thanked for providing his verbal update.

8. PRESENTATION: ENFORCEMENT AND CCTV UPDATE

The Panel received a presentation by the Head of Parking and Enforcement on CCTV and Enforcement Services across the Borough. A copy of the presentation is attached to these minutes.

The presentation included an overview of the CCTV cameras available across the Borough, the assistance it provides to the police in the prevention and detection of crime, the maintenance service that is provided by Chroma Vision and details of the assistance the CCTV control room provides to Hampshire Highways in ensuring that there is no unauthorised night time access to the Fareham/Gosport Bus Rapid Transit (BRT) route by controlling the barriers on the route, closing them when the last bus has departed and raising the barriers prior to the first bus using the route the next day. He also outlined the number of arrests that were made by the police across Fareham and Gosport in 2017 as a result of CCTV footage. Possible income generation opportunities were also highlighted that could offer CCTV monitoring and maintenance services to private companies and businesses that own CCTV equipment that is not being fully utilised.

The Head of Parking and Enforcement outlined the many areas of responsibility that are covered by the Enforcement Service, including fly tipping, littering, dog fouling and removal of abandoned vehicles. There are 2 full time Enforcement Officers who patrol the Borough and issue fixed penalty notices where appropriate.

Health and Public Protection Policy Development and Review Panel

The Panel was reminded that the Public Spaces Protection Order was introduced last year which formed part of a large campaign to reduce instances of dog fouling. The litter campaign was complemented by free pouches being given away to members of the public for disposal of cigarette ends and chewing gum. Members were invited to take samples of the pouches with them to distribute to residents.

The Head of Parking and Enforcement also explained that there were 5 traveller encampments that took place last year which was the highest number in the Borough since 2012. To help combat the number of encampments, concrete bollards have been erected to restrict vehicular access at Stubbington recreation ground and the open space at Fareham Leisure Centre. The Enforcement Team works closely with the Streetscene Team to make sure that gates and barriers that protect vulnerable areas are used effectively.

The Head of Parking and Enforcement was thanked for providing his presentation.

9. HEALTH AND PUBLIC PROTECTION POLICY DEVELOPMENT AND REVIEW PANEL WORK PROGRAMME

The Panel considered a report by the Director of Planning and Regulation which gives a preliminary review of the Panel's Work Programme for 2017/18 and the draft Work Programme for 2018/19.

In reviewing the Work Programme for 2017/18, Members requested that a verbal update on Air Quality be brought to the meeting of the Panel scheduled to take place 06 March 2018.

In giving initial consideration to the draft Work Programme for 2018/19, Members discussed and agreed that the Police Crime Commissioner be invited to a future meeting to give an update on police matters. It was also agreed that a Representative from the Fareham & Gosport Clinical Commissioning Group be invited to attend a future meeting to give an update on health services.

It was AGREED that, subject to the inclusion of a verbal update on Air Quality being added to the agenda of the meeting scheduled to take place on 06 March 2018, the Work Programme for 2017/18, as attached as Appendix A to the report be approved.

Members were invited to put forward any suggested items for inclusion in the draft Work Programme for 2018/19 to the Chairman of the Panel or to the Director of Planning and Regulation in advance of the next meeting.

Subject: FAREHAM COMMUNITY SAFETY PARTNERSHIP

SUMMARY

This report provides Members of the Panel with an overview of the work undertaken by Fareham's Community Safety Partnership

RECOMMENDATION

It is recommended that the Panel notes the progress made by Fareham's Community Safety Partnership and the risks and challenges it faces in the future.

INTRODUCTION

- 1. Fareham's Community Safety Partnership was established in 1998 in response to the Crime and Disorder Act 1998. The Partnership is made up of a number agencies and organisations that work in partnership to tackle crime across the Borough of Fareham by undertaking a strategic assessment in relation to crime and disorder, identifying key local priorities and developing strategies to effectively reduce crimes, anti-social behaviour and criminal damage that have been highlighted.
- 2. The responsible authorities have statutory duties on the Partnership and are Fareham Borough Council, Hampshire County Council, Hampshire Constabulary, Hampshire Fire Authority, Hampshire Fire and Rescue Service, National Probation Service and Community Rehabilitation Company and Fareham and Gosport Clinical Commissioning Group. Invited organisations include, the Youth Offending Team, Neighbourhood Watch, Magistrates Court and Southern Domestic Abuse Service.

AIM AND PURPOSE OF THE PARTNERSHIP

3. The aim of the Partnership is to develop and build upon partnership working between all agencies in order to create a safer Fareham by reducing crime and disorder, including the fear of crime and contribute to making Fareham a safe place to live, work and visit. The importance of the Partnership is reflected in the Council's corporate priority, a safe and healthy place to live and work.

POLICE AND CRIME PANEL

- 4. Councillor Cartwright represents Fareham Borough Council on Hampshire's Police and Crime Panel.
- 5. The Office of the Police Crime Commissioner has not announced where the main Fareham police station will be located. It is likely that it will be at the purpose-built premises at Park Gate with additional premises in Fareham Town Centre once a suitable location has been identified.
- 6. Funding issues continue to be a cause for concern, however the police service is not yet at crisis point and services to people at risk will continue to be provided.
- 7. The Police and Crime Panel is disappointed that there was no measurement of outcomes in the recent review of the Delivery Plan and has been critical of the lack of feedback on completed projects.
- 8. The Police and Crime Panel annual report has been produced and discussed. This includes the role of the Panel, the participants and the Proactive Scrutiny that has been undertaken and can be found on their website.
- 9. The Panel raised concern about the future of the PCSO role in neighbourhood policing, particularly in light of the level of funding that needs to be cut from the budget. The Community Safety Partnership Chairman will write to the Police Crime Commissioner and the Chief Constable to put forward these concerns and to highlight the value the Borough places on the service provided by PCSOs and Neighbourhood Police.
- 10. On the 26 January 2018, the Police and Crime Panel support the precept increase of £12 per annum for a Band D household on the proviso that this sum is spent on Police

Officers and staff.

FAREHAM`S COMMUNITY SAFETY STRATEGY 2018-19

11. With the demise of the County Strategy Group and any analytical resource, the Community Safety Manager has used data from the British Crime Survey, Local Public Health profiles, District Crime figures and quarterly reports from community safety partners. Three priorities for Fareham are;-

(i) **Violent Crime** which is increasing – particularly Youth on Youth violence and

(ii) Anti-social behaviour – including drugs and alcohol related crime.

(iii) Alongside these priorities there will be an over-arching priority to **reduce repeat offending.**

FAREHAM'S PARTNERSHIP ACTION GROUP

12. Fareham's monthly Partnership Action Group is a best practice example of partnership working and an initiative we are very proud of. There is representation from the Chairman of the Community Safety Partnership, Mental Health Service, Children's Services, Adult Services, Enforcement, Environmental Health, Schools, Social Housing, Youth Services, Probation, Youth Offending Team, Community Safety, Youth Crime Prevention, Police, Inclusion and Two Saints amongst many. This forum allows the sharing of information to ensure that people are supported where required and resources allocated. Actions are completed in a timely manner and agencies held to account. Hampshire Constabulary have identified this as an example of best practice and we have received several invitations to attend the meeting from around the county.

FAREHAM SUPPORTING FAMILIES

- 13. The Senior Responsible Officer for Fareham's Supporting Families is the Council's Community Safety Manager. Fareham has joined the Supporting Families Coordination Group and the Early Help Hub which meets each week.
- 14. The programme targets families with problems relating to crime, education and unemployment, domestic violence, children that require help and health issues. Families have plans which set out what the key worker or lead agency will do and what the family will do. The programme looks to ensure that children attend school regularly, parents are provided with training so they can get back to work, there are lower levels of crime and anti-social behaviour and that families work better as a unit, able to look after and support each other.
- 15. Fareham Supporting Families has engaged with 202 families since the start of the programme. The new phase intensive support service commenced on 1 April 2017. The commissioned providers for the Intensive Support Service are Motiv8 and Careers South West Group Limited.
- 16. All Fareham and Gosport PCSOs have been trained to lead on 2 families each.

DOMESTIC HOMICIDE REVIEWS

17. Since April 2011, Community Safety Partnerships have been responsible for undertaking domestic homicide reviews. A clear process has been drafted and contacts made with organisation leads. The Community Safety Manager and Head of Environmental Health are named as points of contact with Hampshire Constabulary, as is the Chairman of the Community Safety Partnership, Councillor Cartwright.

PREVENT

- 18. The Counter-Terrorism and Security Act 2015 contains a duty on specified authorities to have due regard to the need to prevent people from being drawn into terrorism. The government has produced guidance for specified authorities, which they must have regard to when complying with the duty. The duty applies to bodies which have significant interaction with people who could be vulnerable to radicalisation. This ensures that the duty is proportionate. These include schools, local authorities, police forces, some NHS bodies, further and higher education providers, prisons and young offender institutions and providers of probation services. As a District Council, we have an important role to fulfil to ensure that none of our buildings (including our community centres and or our housing stock) are used by extremist groups to promote terrorism.
- 19. The Community Safety Manager has undertaken the Home Office WRAP Training and delivered combined safeguarding and Prevent training to frontline staff, Councillors and head teachers of Fareham Schools and Colleges. The Partnership Action Group will discuss referrals and refer high risk cases to Hampshire's Multi Agency Safeguarding Hub so they can access support through the Channel Panel.
- 20. Counter Terrorism Local Profile prepared by the Police has identified areas for community safety partners to deliver and is co-ordinated in a concise Action Plan which looks at delivering training, updating our safeguarding policy and procedures, ensuring the Council's community buildings are being let appropriately and an engagement plan highlights any emerging community groups. There is also a requirement for emergency planning and community safety to work closely.
- 21. The Home Office undertook a Peer Review in 2017 which lead to several recommendations including setting up a County Strategy Group to provide appropriate governance to the Prevent Strategic Partnership Board.

MODERN SLAVERY, CHILD SEXUAL EXPLOITATION

- 22. Child sexual exploitation and slavery exist in the South East and across all other parts of the UK and involves children and adults. Concerns will be reported through the Council's existing safeguarding process. More information for staff about identifying signs of potential slavery has been incorporated into the Safeguarding Children and Adults Policy and training materials in relation to raising awareness for taxi drivers is being developed by the Community Safety and Licensing Teams.
- 23. The Local Government Association has provided a guidance document relating to Modern Slavery for local authorities.

COMMUNITY SAFETY INITIATIVES

- 24. SNAP discos are held at Ferneham Hall and attract a large number of young people on selected Friday nights throughout the year. The Events Team deliver this on behalf of the Community Safety Partnership.
- 25. The Community and Leisure Team delivered Access All Areas in summer 2017 at venues throughout Fareham, this initiative continues to be successful year on year.

- 26. The Community Safety Team currently sits with colleagues in Environmental Health which has proven to work well as a number of cases overlap and can be resolved together. The Vanguard way of working has resulted in a large portion of community safety work being of a preventative nature, with early intervention, trying to understand behaviours and their causes and working with persons causing Anti-Social Behaviour, to behave in a more community friendly way. Mediation has featured strongly and been a successful way of resolving issues and allowing neighbours to live in harmony with one another.
- 27. Fareham Neighbourhood Watch has been encouraged to work independently with support from the Community Safety Manager and local Police Inspector. Their website http://www.farehamnhw.co.uk/ has proven popular and Chairman Carol Allington has delivered a successfully co-ordinators meeting and will chair the AGM on 30 March 2018 at 7pm at Ferneham Hall.
- 28. As a result of a rise in crime associated with street drinking, begging and taking of drugs in Fareham, the Council, together with Community Safety Partners consulted on, and finalised, a Public Spaces Protection Order. The first priority is to offer support around substance misuse, housing and benefits to the individuals. When all avenues of support have been exhausted and individuals affect the lives of residents, visitors and businesses, we now have enforcement powers which we can use. Signs have been erected around the town centre, officers delegated with new powers and positive communication and public awareness has been undertaken to reassure the public and encourage them to report incidents.
- 29. We are also working with the Pharmacies Network to ensure the needle exchange programme is working efficiently, Public Health England to ensure that the services commissioned are appropriate and the Department for Works and Pensions to ensure we are preparing for Universal Credit.
- 30. We are working with Two Saints, Housing, Police and Inclusion in relation to tackling anti-social behaviour and rough sleepers. The Housing Options Manager is setting up a partnership group discussion to address emerging issues promptly.

BUDGET, FINANCIAL IMPLICATIONS, CHALLENGES AND OPPORTUNITIES

- 31. Fareham Community Safety Partnership holds £10,000 to discharge its statutory function imposed by the Domestic Violence, Crime and Victims Act 2004 to establish a Domestic Homicide Review should one need to be undertaken in Fareham.
- 32. All partner agencies are suffering cuts in funding. As a partnership we are attempting to find ways we can work together to address the areas where there are gaps.

CONCLUSION

- 33. We need to ensure that our local priorities have a direct correlation with the Police and Crime Commissioner's priorities.
- 34. At Fareham the co-location of services is working well and needs to be further developed inviting more agencies into the building. Innovative ways of working, including sponsorship and monitoring risks and performance will ensure that the Partnership continues to progress. Fareham currently has the Community Rehabilitation Company, Youth Offending Team, Integrated Offender Management,

Public Health England and MOTIV8 co-located in the Civic Offices. It is unfortunate that Police has not entered the building.

- 35. Ensuring that the residents of Fareham feel part of the CSP and contribute to reduction in Crime is essential. Community engagement and empowering residents is vital. We will work to improve how residents can report crime, access local crime statistics and take part in community safety initiatives and consultations. Sharing of information between partner agencies, mainstreaming community safety within Fareham Borough Council will also ensure that all Officers and Councillors know what the Partnership priorities are and how together they can impact positively upon them. The Community Safety Manager has worked with the Office of the Police and Crime Commissioner to improve Safetynet and produce a package of data and information that will, in future, inform our community safety strategy and priorities.
- 36. Fareham remains a safe place to work, live and visit; however, the Partnership cannot be complacent and must ensure that all initiatives are evaluated and it can prove that its intervention does make a difference.

	Those businesses that are able to demonstrate sustained compliance will be recognised by a reduction in the regulatory burden on them. For some businesses, the risk will be so low that they do not merit inspection. For others, inspection could be more intrusive and rigorous.
	A wider range of information sources will be used to base judgements on Food Safety and Standards, including Private Assurance Schemes, Primary Authority arrangements and Certified Regulatory Audits.

Action by Panel	The Panel received a presentation from Chief Inspector Sharon Woolrich from Hampshire Constabulary.
	Chief Inspector Woolrich provided members with an overview of public protection matters, reporting that crime is increasing in Fareham, as it is across all Districts in Hampshire. This is against a backdrop of Hampshire Constabulary being the third lowest funded Force nationally with one of the lowest ratios of officers per 1000 population and the highest crime rate ratio to officer numbers. The Police Crime Commissioner and the Chief Constable continue to work to secure a correction in the level of funding for Hampshire but it is unlikely that this will be achieved in the short term and the Force will still be required to make further cuts of £21m from the budget over the next 2 years.
	Members were provided with data illustrating the level of calls for service received by the Force during the 12 month period ending September 2017. Fareham is well served for calls that are considered to present an immediate risk to life, with 91% of calls responded to within the 20 minute target time. This compares to a county performance of 76%.
	Levels of crime are increasing, although at a slower rate in Fareham than the rest of the County. Some of the increase relates to vulnerability issues such as child exploitation, child abuse and domestic abuse. This is an area that HMIC has previously highlighted as requiring improvement in Hampshire and the work done by the Force to target this type of criminal activity partly explains the increase in the numbers of cases being reported and pursued.
	Chief Inspector Woolrich gave an overview of safeguarding which explained the purpose of Sarah's Law (Right to Ask), Claire's Law (Right to Know) and provided an overview of Operation Encompass which deals with early communication with schools where a child has been involved in a domestic abuse situation so that provision can be made to ensure the child is supported and feels safe. Chief Inspector Woolrich also reported that Child Abduction Notices (CAWNS) have increased from 43 in 2016 to 98 in 2017. CAWNS are an early intervention used by police to disrupt contact between an adult and a vulnerable child.
	Members commented on the difficult job that the police force is still expected to do despite the cuts in funding that have already taken place and with further cuts planned over the next two years.
	Councillor Davies raised concerns regarding a series of thefts from work vans that are parked at residential premises overnight. Councillor Davies invited police advice on how this type of crime can be prevented. Chief Inspector Woolrich reported that this is a known issue and police advice to the public is to leave vans at work overnight rather than take them home. Where this is not possible, people are advised to remove the tools from vans overnight.

The Enforcement Team works closely with the Streetscene Team to make sure that gates and barriers that protect vulnerable areas are used effectively. The Head of Parking and Enforcement was thanked for providing his presentation. 	
	 The presentation included an overview of the CCTV cameras available across the Borough, the assistance it p to the police in the prevention and detection of crime, the maintenance service that is provided by Chroma Vis details of the assistance the CCTV control room provides to Hampshire Highways in ensuring that there is no unauthorised night time access to the Fareham/Gosport Bus Rapid Transit (BRT) route by controlling the barrie the route, closing them when the last bus has departed and raising the barriers prior to the first bus using the route, closing them when the last bus has departed and raising the barriers prior to the first bus using the next day. He also outlined the number of arrests that were made by the police across Fareham and Gospor 2017 as a result of CCTV footage. Possible income generation opportunities were also highlighted that could CCTV monitoring and maintenance services to private companies and businesses that own CCTV equipment not being fully utilised. The Head of Parking and Enforcement outlined the many areas of responsibility that are covered by the Enform Service, including fly tipping, littering, dog fouling and removal of abandoned vehicles. There are 2 full time Enforcement Officers who patrol the Borough and issue fixed penalty notices where appropriate.
