(1) Introducing Simpler Recycling in Fareham

There were no comments or questions for clarification in respect of this item.

7. MOTION: PROSTRATE CANCER UK'S 'BINS FOR BOYS' CAMPAIGN

At the invitation of the Chairman, Councillor Mrs K K Trott addressed the Panel on this item.

The Panel considered a report by the Director of Neighbourhoods which outlined the Council's current provision of sanitary waste bins in male public toilets across the Council's own buildings. The report also set out the implications of supporting the Motion presented to Council by Councillor Mrs K K Trott on 14 December 2023 in respect of Prostate Cancer UK's 'Bins for Boys' campaign.

Members were supportive of the current trial that is being undertaken and discussed the need to ensure that the publicity surrounding the Council's position is timely and appropriate.

RESOLVED that the Streetscene Scrutiny Panel:

(a) notes that the current trial, as detailed at paragraph 10 of the report, will be continued for a period of 12 months;

- (b) notes that a further report will be brought forward for consideration once the results of the trial are known; and

Demand Data

- 1,202 plots available on FBC owned land
- Over 100 plots in private ownership
- Average waiting time on most FBC owned plots is
 5 months (15 months including Stroud Green)
- 53 people on the waiting lists across most of the 3 main associations (127 including Stroud Green)
- Average number waiting on FBC owned sites is 13





- Plot numbers and waiting lists change regularly
- Plots can vary in size between 2.5 rods and 15 rods.
 10 rods is approximately 250sqm
- Large plots can be sub-divided to provide more allotments

Allotment Associations are responsible for:

- management and maintenance of the sites
- internal décor of Council owned buildings
- all associated utility bills
- The Council is responsible for:
 - structural repairs and external decoration to all Council owned buildings
 - any significant works such as major subsidence or significant site layout changes



Stubbington Allotment Provision

- Only 1 small site, Stroud Green, is available to serve the community of Stubbington
- Long waiting list
- Attempts to secure appropriate additional land in the area have been unsuccessful to date
 - Residents objected to the use of the adjacent open space to extend the existing site
 - Land near Daedalus was deemed too expensive
- New allotment provision is planned for the Longfield Avenue development north of Stubbington with good access from the Stubbington & Hill Head Wards. The proposal is currently at Outline Application stage.
