**Purpose:**

This report sets out the results of the recent Traffic Regulation Order (TRO) engagement exercise for the Draft Off-Street Parking Places (Amendment 9) Order. The Amendment Order sets out proposals to change the 'limited wait 2 hours, no return within 4 hours' at Middle Road Car Park, Park Gate to apply between the hours of 8am and 6pm only

**Executive summary:**

The Executive meeting on March 2024 agreed that the following changes should be applied to the existing Off-Street Parking Order:

- to change the limited wait and no return to '2 hours limited wait, no return within 4 hours between the hours of 8am and 6pm.

The statutory process to inform the public of these changes took place through the Draft Off-Street Parking Places (Amendment 9) Order consultation which ran from 22 March 2024 – 12 April 2024.

The proposed order and details of how to take part were placed on the Council's website. A notice was published in the Hampshire Independent and consultees including Hampshire Constabulary, Hampshire County Council, the Road Haulage Association, and the Freight Transport Association were contacted. Public notices were posted in Middle Road Car Park, Park Gate.

Hampshire County Council responded to confirm that they had no objections to the Amendment Order. No other responses were received.

If the Amended Off-Street Parking Places (Amendment 9) Order is approved, revised signage will be put in place in Middle Road Car Park. The Council's website will be

updated to ensure that parking information reflects the amended Off-Street Parking Places (Amendment 9) Order. Changes will come into effect on the 24 May 2024.

**Recommendation/Recommended Option:**

It is recommended that the Executive Member for Health and Public Protection agrees the adoption of the updated Off-Street Parking Places (Amendment 9) Order as attached at Appendix A to the report.

**Reason:**

To better support the evening economy at Park Gate whilst continuing to support the turnover during the day when a survey has shown it is currently very busy.

**Cost of Proposals:**

The costs of revised signage will be met within current budgets.

**Risk Assessment:**

There is a risk that if the Off-Street Parking Places (Amendment 9) Order is not agreed, there will be a negative effect on the evening economy in Park Gate.

**THE BOROUGH OF FAREHAM  
(OFF-STREET PARKING PLACES) (AMENDMENT 9) ORDER 2024**

Fareham Borough Council in exercise of its powers under Sections 32, 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (“the Act”) and of all other enabling powers, with the consent of the Hampshire County Council pursuant to Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:

**CITATION**

- 1 This Order shall come into operation on XX 2024 and may be cited as The Borough of Fareham (Off-Street Parking Places) (Amendment 9) Order 2024.

**INTERPRETATION**

- 2 In this Order:
- (i) “Principal Order” shall mean The Borough of Fareham (Off-Street Parking Places) Consolidation Order 2017 (as amended).
  - (ii) Except where otherwise stated, any reference to an Article or Schedule shall be construed as a reference to that Article or Schedule in this Order.
  - (iii) Any reference to an enactment shall be construed as a reference to that enactment as amended by any subsequent enactments.

**AMENDMENTS**

- 1 The provisions relating to Middle Road Car Park, Park Gate in Schedule 5 of the Principal Order shall be deleted and replaced by the contents of Schedule 1 to this Order.

Middle Road Car Park, Park Gate	All Vehicles except a) Goods Vehicles exceeding 1525kg unladen weight; b) Passenger Vehicles adapted to carry more than 12 passengers exclusive of the driver; and c) Trailers	Wholly within a bay not reserved for any other class of Vehicle or person.  Motor Cycles may only wait within a Bay marked "Motor Cycles Only"	2 hours, no return within 4 hours between the hours of 8am and 6pm.
