WE LIVE DIRECTLY OPPOSITE THE CLUB, AND ARE DIRECTLY AFFECTED BY NOISE FROM THE CLUB ITSELF, ANTI-SOCIAL BEHAVIOUR OF INTOXICATED CUSTOMERS LOITERING AROUND THE ENTRANCE, AND ENGINE NOISE OF TAXIS WAITING AND PICKING UP IN THE ROAD (DOUBLE-YELLOW RESTRICTION) LATE AT NIGHT.

IN THE PAST, THERE HAVE BEEN NUMEROUS INCIDENTS OF FIGHTS OCCURING IN THE ROAD, CAUSED BY CUSTOMERS OF THE CLUB LINGERING AFTER IT HAS CLOSED. ON MORE THAN ONE OCCASION, THESE HAVE SPILLED ONTO OUR PROPERTY, AND THE PROPERTIES OF OTHER ADJACENT RESIDENTS. THE POLICE HAVE BEEN CALLED, AND RESPONDED, ON THESE OCCASIONS, HOWEVER, UNFORTUNATELY WE DO NOT HAVE RECORDS OF THE NUMBER, FREQUENCY, OR DATES OF THESE EVENTS.

TO ITS CREDIT, THE CLUB HAS TAKEN STEPS TO MITIGATE THE RECURRENCE OF SUCH INCIDENTS, AND THE SITUATION IS GENERALLY CONSIDERED 'LIVEABLE', AT LEAST BY US AT 37 MILL RD. ALTHOUGH THERE IS STILL REGULAR DISTURBANCE CAUSED BY DRUNK CUSTOMERS LINGERING OUTSIDE THE CLUB AFTER IT HAS CLOSED, AND TAXIS WAITING IN THE ROAD, INSTEAD OF IN THE CLUB CAR PARK, IT HAS NOT BEEN BAD ENOUGH TO MOTIVATE US TO COMPLAIN.

HOWEVER, WE STRONGLY OPPOSE ANY CHANGE TO THE CLUB'S ALCOHOL LICENCING TIMES THAT MAY INCREASE THE LIKELIHOOD OF MORE PEOPLE BECOMING INTOXICATED ON THE PREMISES IN THE NIGHT TIME, ESPECIALLY DURING WEEKDAYS (WHEN YOUNG CHILDREN ARE TRYING TO SLEEP). THE INEVITABLE RESULTANT DISTURBANCE TO LOCAL RESIDENTS WOULD BE UNREASONABLE, AND WILL NOT BE TOLERATED.

UNFORTUNATELY, WE DO NOT HAVE ORGANISED RECORDS OF DISTURBANCE INCIDENTS. WE HAVE NOT BEEN MOTIVATED TO KEEP SUCH RECORDS, IN FAVOUR OF A 'LIVE AND LET LIVE' ATTITUDE. WE DO NOT WANT TO INTERFERE WITH A LEGITIMATE BUSINESS, OR PEOPLES' LEISURE ACTIVITIES. WE SIMPLY EXPECT RESPECT FOR LOCAL RESIDENTS.

HOWEVER, WE WILL START TO MAKE RECORDS, AND SET UP PERMISSIBLE AUDIO/VIDEO RECORDING FACILITIES IF THIS BECOMES NECESSARY.
