2014 - Vanguard System Thinking Review

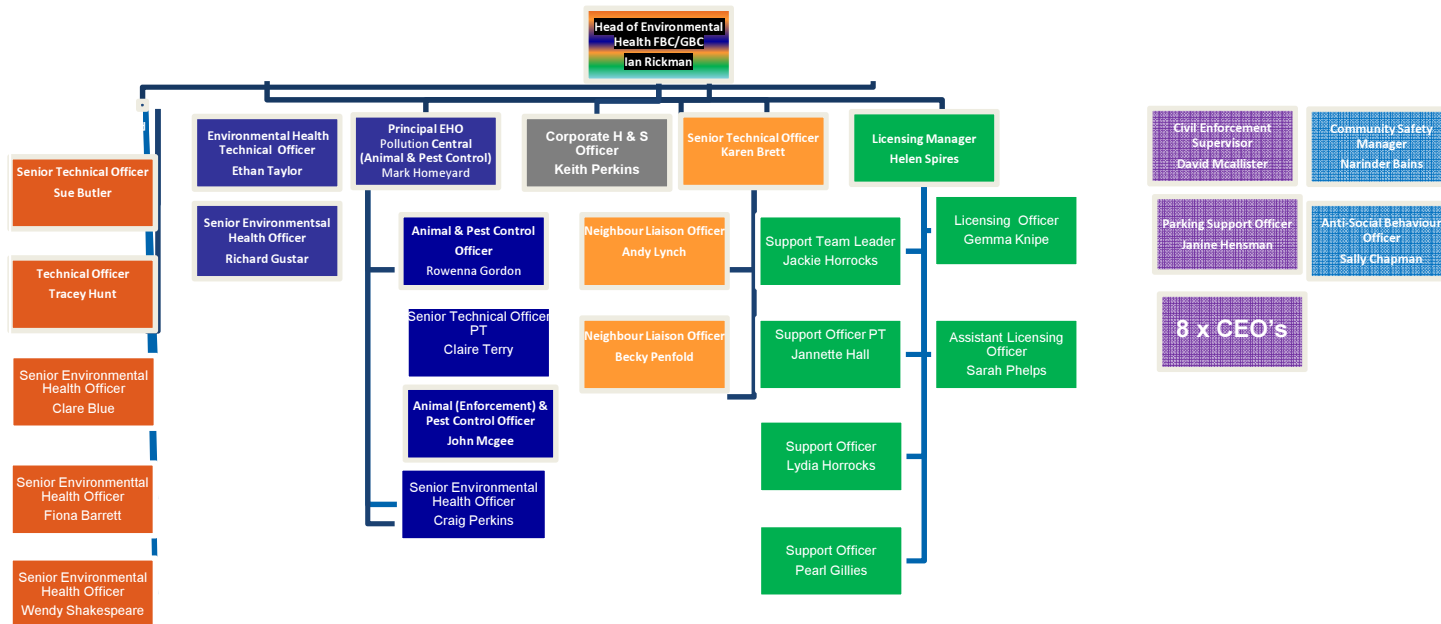
2015 – Restructure

## Financial Information

- Kept simple
- Costs split 50/50
- Income retained by Council that generate it.
- Cost of Service approx. 1.6m, savings over last 5 years approx. 50%.
- Procurement mainly through Fareham
- Own Licensing Panels/sub-board
- Own Legal Services

# Current Performance

- Food Inspections should be about 97% completed 31/03/18
- Complaint work reactive up to date (5000).
- 1450 domestic noise / 1291 pest control
- OOH EH 250
- Dogs OOH – 78
- Licensing Stat time periods met 17/18
- Licensing no back logs anywhere
- AQ single contract F&G – AQMA's
- Compliance Directive
- Prosecutions -Lime Tree Gosport , One Stop and Hoeford Fareham (FC)
- Customer feedback is good
