# Highway Authority note addressing queries relating to the southern site Unilateral Undertaking.

The Inspector requested further clarification and information in relation to the highway related obligations included in the document 'UU Newgate Lane South Final Unsigned' in the form of:

- Confirmation that the Highway Authority (HA) are satisfied with a contribution of £90,789 towards the provision of a Toucan crossing of Newgate Lane East at Woodcote Lane and Brookers Lane should the southern site come forward in isolation.
- Provision of a breakdown of the agreed cost estimate and a works plan for the improvements to school routes.
- Evidence regarding how the southern Travel Plan security payment (bond or cash deposit) was calculated.

#### **Toucan Crossing**

I can confirm the HA are satisfied that a contribution value of £90,789 is sufficient to mitigate the impact of the development in relation to the southern site in isolation. Additional funding may be available in the future to make up the shortfall required to implement a toucan crossing at this location. Should this not be forthcoming, the HA are satisfied adequate alternative pedestrian and cycle improvement measures to mitigate the impact of the southern site in isolation can be implemented at the Woodcote Lane/ Brookers Lane crossing of Newgate Lane East; such possibly measures include additional signage, high friction surfacing, lighting and increasing the width of the existing refuge island.

In order to cover the eventuality that the southern site is progressed in isolation and that alternative pedestrian and cycle improvement measure are required, the wording of the obligation should be amended to remove the specific requirement for a Toucan crossing. The HA is willing to agree alternative wording of this contribution with the appellant.

#### **Improvements to School Routes**

The following cost estimate, totalling £347,462 was produced by the HA and agreed by the Appellant.

#### Gosport Road Section:

- Enlarged Pedestrian refuge £4,000 (replacing existing)
- Footway widening (to form 3m wide shared route) £32,000 (160m replace verge with footway construction)
- Footway widening (to form 2.5m wide shared route) £42,000 (140m widening existing footway into c/way & reducing size of bus stop)
- Footway Resurfacing (existing areas) £20,000
- Lighting Column relocation £2,500 (assuming 2No. re-use and service OK)
- Signs & road markings £2,000
- Traffic Management (20% of works cost £102,500) £20,500
- TOTAL (Excludes fees & SU Costs) £123,000
- Design and supervision fees (19.5%)
- SU Costs (30%)
- TOTAL (Including fees & SU Costs) £183,885
- TOTAL COST (including optimism bias at 44%) £264,794

### Bells Lane/Stubbington Lane/Eric Road Junction:

- Enlarged Pedestrian refuge £12,000 (replacing existing 3No.)
- Footway widening (to form 3m wide shared route) £14,000 (70m replace verge with footway construction)
- Footway Resurfacing (existing areas) £5,000
- Signs & road markings £1,000
- Traffic Management (20% of works cost £32,000) £6,400
- TOTAL (Excludes fees & SU Costs) £38,400
- Design and supervision fees (19.5%)
- SU Costs (30%)
- TOTAL (Including fees & SU Costs) £57,408
- TOTAL COST (including optimism bias at 44%) £82,668

The HA accept there is a wider benefit to these improvements and as such a total contribution of 50% of the full cost estimate was considered adequate mitigation, giving a contribution for both proposed developments in combination of £173,731. This was then split by the proposed number of dwellings for the southern site in isolation, giving an agreed contribution of £105,153.

A plan of the proposed improvement works is attached.

# **Southern Travel Plan Security Payment**

The costed Travel Plan measures for the southern site are shown in table 5.1 below, extracted from the agreed Framework Travel Plan.

The Travel Plan delivery costs are summarised as follows:

• The provision of 'Welcome Information Packs': £2000

• The general publicity and promotion budget: £5,000 – 15,000

Sustainable Travel Vouchers: £5,750
 Travel Plan coordinator costs: £25,000

For the purposes of calculating the required surety (bond or security deposit) value, the maximum forecast general publicity and promotion budget (£15,000) was used to give certainty sufficient funds would be available should the HA be required to deliver the Travel Plan.

Summing the above costs gives a total value of £47,750 as agreed with the appellant and set out within the 'Travel Plan Bond' and 'Travel Plan Security Deposit' definitions of the southern application UU.
