Subject: REVIEW OF WORK PROGRAMME

SUMMARY

This report reviews the current work programme for the Committee.

RECOMMENDATION

INTRODUCTION

1. This report brings the latest work programme for review by the Committee.

WORK PROGRAMME 2021/22

- 2. The progress on the work programme for the year is shown in Appendix A. This shows the reports expected in relation to each of the functions of the Committee along with an update on the delivery of the programme.
- 3. There have been three changes to the programme approved in the July 2021 meeting. The first change concerns the appointment of the External Auditors for the contract between April 2023 and March 2028. The current appointment was made following a tender exercise led by Public Sector Audit Appointments. Fareham Borough Council, along with 98% of other Councils, opted-in to their tender process and recommendation. Public Sector Audit Appointments have started consultation for the next round of appointments.
- 4. The Council will therefore need to decide whether we again opt-in to this process or decide to carry out our own tender. We are expecting the Council to be asked to make this decision by January 2022, so we have provisionally scheduled a report to come to the Committee in November. The final decision will be made by Full Council, so this decision has been added to the published Forward Plan.
- 5. The other two changes are reports that have been postponed to the next meeting:
 - Inspection Report (RIPA) we have not yet received our 3-yearly RIPA inspection. We will, however, shortly be re-engaging with the Investigatory Powers Commissioner's Office to carry out this work.
 - **Risk Management** officers have started work to resume the risk management discussions which feed into the six-monthly monitoring reports. These will not be completed in time for the September meeting, but we are expecting to complete the cycle in the next two meetings.
