Hi Mick,

We have had some discussions in the past regarding the proposed development at Oakcroft Lane, which is currently being considered under application P/20/0522/FP, and the transfer of land to FBC. I have now had further details regarding the final layout of the land which is proposed to be transferred in the event that Planning Permission is granted.

If you could have a look at the following plans (which can be viewed on line here: http://www.fareham.gov.uk/casetrackerplanning/ApplicationDetails.aspx?reference=P/20/0522/FP &uprn=10012131685) I would appreciate the on-going maintenance costing for the land.

- 1. Landscape Plan for Northern Open Space;
- 2. Habitat Plan (North);
- 3. Habitat Plan (South);

On the Habitat Plan (North) the land to be transferred to FBC would be all the pink land north of Oakcroft Lane (with the exception of an attenuation pond (for road drainage) to the southeast corner of the site), and on the Habitat Plan (South), the land to be transferred to FBC would be the orange strip of land to the southern part of the site including the LEAP, and the yellow hatched woodland area to the south beyond this). The permanently wet part of the attenuation pond would be excluded from the transfer. Mark Trigwell and Paul Johnston have already provided me a maintenance costing for the woodland area (the yellow hatched area). The remaining orange land within and the northern, eastern and western boundaries would be transferred to a private management company paid for by the future residents.

Please can you let me have your costing by the 19th October in order that the figure can be added to the drafting of the S106 agreement. If you have any queries, please let me know.
