Good morning Jane,

Firstly I have received confirmation from John Powell that the developer is in agreement to the revision tabled during discussions. I have included the text from his e-mail below.

The revision agreed to the original request for a contribution is agreeable to HCC Children's Services as a contribution towards addressing building suitability issues at Peel Common Infant and Junior Schools, particular towards resolving matters of undersize halls at both schools and to address a shortfall in small group teaching spaces. This resulted from discussions with the developer and part of the reason for agreeing the reduction was to do with the level of contributions they are making towards improving pedestrian and cycling routes to schools. In addition, the relatively small level of additional pupils generated from the development at secondary level means the school could more easily cope with the extra pupils so this element was removed.

The resulting agreed contribution, including £20,000 for school travel plans, reflects those matters and provides a suitable basis for seeking similar contributions from further development in the area.

Good afternoon Glenn,

Thank you very much for your time last week, and the helpful discussion we had regarding the education contributions arising from my client's site. After reviewing matters, my client is happy (on a without prejudice basis) to agree to the proposed contribution of £120,000. This being made up of £20,000 towards home to school travel plans for two primary (including infant and junior combined schools) and one secondary school, and a further £100,000 towards building work at Peel Common Infant and or Junior schools.

It would be very helpful for both the planning application determination, and for any potential further examination of this matter (be it Judicial Review or Planning Appeal) if you could provide a form of words to explain the £100,000 figure and its likely intended use.
