Thank you for sending through the additional information.

Having reviewed the submitted letters, I am still unable to accept that the mitigation for loss of functionally linked SPA habitat is sufficient. I also refer your ecologist to the comments made by Natural England dated 22nd April, which broadly mirrors my concerns in relation to the small size of onsite and offsite bird mitigation areas and their suitability.

In relation to the outstanding protected species surveys, I acknowledge that these are currently being carried out; however, full results of the survey work is required prior to decision making.

Based on the above, I have no further comments to make and encourage that the mitigation for loss of SPA supportive habitat is revisited and Natural England are contacted (through their discretionary advice service) to agree on appropriate mitigation measures. I would be happy to provide an updated response once the results of the survey work is submitted.
